#### **City Council Passes New Codes**



On June 27, 2007, the City Council voted to pass the new NYC Construction Codes! The current building code was last updated in 1968.

The process of modernizing the code began four years ago. The new codes reflect the expertise of over 400 professionals from real estate, labor, industry, academia and government. View a

### Register to Become a Construction Superintendent

#### We're Dedicated to Safety

To ensure that construction sites are supervised by qualified professionals, all new buildings and demolition projects up to and including 14 stories will need to be supervised by a registered Construction Superintendent. ## Notification To Be Required for Outrigger Beams & C-Hook Scaffolds

#### We're Dedicated to Safety

To ensure the safety of the public and the workers who use suspended scaffolds, effective July 16, 2007, notification to the Department of Buildings will be required within 24 - 48 hours before the use or installation of c-hook and outrigger beam scaffolds.
