UPDATE ON CITY'S RESPONSE TO SEVERE WEATHER

In the wake of Wednesday's storm, Buildings inspectors and engineers conducted assessments of buildings in the affected area, and as a safety precaution, issued vacate orders to those buildings that sustained serious damage or damage that prevents safe occupancy. In order to re-occupy vacated buildings, property owners need to:

- · Hire an architect or engineer to assess the damage
- · Provide a remediation plan for repair work
- File applications with the Department of Buildings
- Obtain permits to conduct the necessary repair work

Repair work cannot commence without filing applications and obtaining permits. To speed repair, the <u>Brooklyn Borough Office</u> will facilitate job filings for remedial work. If your building was vacated because of storm-related damage or if you need to retrieve personal belongings from vacated buildings, please call 311 or the Buildings Customer Service Center at (212) 227-4416. Buildings Customer Service representatives will be available to assist those affected by the storm Monday - Friday from 8am to 8pm and Saturday - Sunday from 9am to 5pm. Jail Sentence For Scaffold Death

Information You Need To Know

On July 24, 2007, Nasir Bhatti and Tariq Alamgir, owners of Metla Construction Inc., were sentenced to six months in jail for the death of construction worker Mohammad Jabbie. Jabbie, who fell from a scaffold in June 2005, was not wearing a safety harness at the time of the accident. In December 2006, Bhatti and Alamgir pleaded guilty to charges relating to the scaffold fatality. For more information about the guilty pleas, view the press release from the U. S. New Required Items for New Building and Alteration-1 Applications

Information You Need To Know



In an effort to provide a cleaner and more energy-efficient New York, beginning September 4, 2007, the Department of Buildings will require that all New Building and Alteration-1 Applications include an Energy Analysis and a drawing set that demonstrates the use of the information outlined in the Energy Analysis. These documents must be submitted in conjunction with the Professional Statement of Energy code compliance (currently

Manhattan Borough Office Pre-Filing Process Change

Making it Easier

In an effort to reduce the Pre-Filing wait time, the <u>Manhattan Borough Office</u> now pre-files and processes the following Alteration-3 applications as drop-offs: Fences, Sheds, Hoists, and Scaffolds. If you are pre-filing one of these job applications, leave the documents with a customer representative at the Pre-Filing desk and it will be reviewed and available for pick-up the next business day.

After-Hour Work Variance Permits

Information You Need To Know

After-Hour Work Variance permits for cranes are issued by the Cranes and Derricks Division and by the Borough Offices, depending on the nature of the work. Applications for variance permits to modify a crane should be submitted to Cranes and Derricks and applications to use a crane for after-hours construction work should be submitted to the appropriate Borough Office. "No Penalty" Retaining Wall Inspection Program



Take advantage of our "No Penalty" Retaining Wall Inspection Program before it ends on September 3, 2007! For the duration of the inspection program, homeowners may call 311 and request a visual examination of their private retaining wall by a Buildings Department inspector. Under the "No Penalty" program, violations will not be issued for the condition of the retaining wall. View the press release
