Manhattan Borough Office Launches B-SCAN



On Monday, October 22, 2007, Buildings Commissioner Patricia J. Lancaster announced the launch of the final phase of the Buildings Scan and Capture Application Network (B-SCAN) in the Manhattan Borough Office. B-SCAN enables Buildings staff to scan most documents (except for

architectural plans) associated with New Building and Alteration jobs for the public and professionals to retrieve online. As a major component of the Department's 2006-2009 Strategic Plan (2,746 kb-pdf), B-SCAN has already been implemented in the Bronx, Brooklyn, Queens and Staten Island. Since it was first launched in April 2007, more than 5,732 construction permit applications have been scanned. That's more than 63,161 pieces of paper now available to you online via BISWeb! To ensure construction sites are supervised by qualified individuals, beginning January 2, 2008, all New Building and Demolition applications for buildings 14 stories and below will be required to have a registered Construction Superintendent named in section 9a of the <u>PW-2</u> form.
