#### **Stop Work Order Patrol Expands to Manhattan**



On November 1, 2007, the Stop Work Order Patrol began proactively monitoring construction sites with active Stop Work Orders in Manhattan to ensure work sites are brought into compliance. The Stop Work Order Patrol partners Department of Finance deputy sheriffs with Buildings inspectors to conduct unannounced inspections of construction sites with active Stop Work Orders and issues follow-up violations with escalated civil penalties if work continues while the Stop Work Orders are in effect. Initially

launched in Queens in 2006, the Patrol was expanded to Brooklyn, the Bronx, and Staten Island over this past year. Now operating citywide, the Stop Work Order Patrol is an integral component of the Department's <u>Special Enforcement Plan</u>. View the <u>press release</u> for more information.
