### **Lightweight Materials Pilot Launch**



On November 20, 2007, Buildings Commissioner Patricia J. Lancaster and Fire Commissioner Nicholas Scoppetta launched the Lightweight Materials Pilot Program in Staten Island. The new program partners Buildings inspectors and engineers with Fire Department firefighters to conduct joint inspections of construction sites in Staten Island where lightweight construction materials are being used to erect new

#### **B-SCAN Reaches Milestone**



On November 21, 2007, Buildings Commissioner Patricia J. Lancaster joined Department staff to celebrate a technological milestone by scanning the 100,000th document into the Buildings Scan and Capture Application Network (<u>B-SCAN</u>), an electronic document management system that makes most paper documents associated with construction permit applications immediately available online for public access. As

a component of the Department's 2006-2009 Strategic Plan

#### New Sidewalk Shed Safety Statement

#### Dedicated to Safety

To protect public safety, the Buildings Department recently sent <u>letters</u> (23 kb-pdf) to construction shed companies and building owners with sidewalk sheds installed prior to July 1, 2007 reminding them that sheds must have adequate lighting. Sidewalk sheds that do not comply with the <u>Building Code</u> and Electrical Code or do not have an associated electrical permit must be inspected by a licensed electrician. Shed companies and building owners must also submit a <u>Sidewalk Shed Safety Statement</u> (10 kb-pdf) on the Licensed Electrician's company letterhead indicating the shed does not pose a hazard. This must be submitted to the Buildings Department <u>Electrical Unit</u> by December 31, 2007.

#### **Street Obstruction Bonds No Longer Required**

To simplify our permitting process, the Buildings Department now no longer requires permit applicants to provide Street Obstruction Bonds.

### **Temporary Heat in High Rise Buildings**

To provide temporary heat in a high rise building under construction during heat season (October 1st through May 31st), plumbing contractors may install salamanders connected to cooking gas risers or may use the building's boiler.
