# **Robert LiMandri Named Buildings Commissioner**




On October 8, Mayor Bloomberg <u>swore-in</u> Robert LiMandri as Commissioner of the Department of Buildings. LiMandri, who has more than 19 years of engineering, real estate and construction management experience in the private and nonprofit sectors, has served as Acting Commissioner since April 2008 and has been part of the Department of Buildings' <u>senior management</u> since 2002.

## New Criteria for Class C HMO Licenses

On October 6, Commissioner LiMandri announced <u>strict new criteria</u> for individuals seeking licenses to operate Class C hoist machines, commonly referred to as mobile cranes. New York City is one of only 19 jurisdictions nationwide that restricts the operation of cranes to licensed individuals. # License Term and Fee Changes

Information You Need To Know All Master and Special Rigger, Master and Special Sign Hanger and Tower Crane Rigger licenses will be extended to three-year terms beginning January 1, 2009. ## **General Contractor Registration Renewal**

#### Information You Need To Know

General contractors registered with the Department seeking to renew their registration must now follow new procedures (22 kb-pdf). To avoid a late fee, renewal applications must be submitted 30 to 60 days before the expiration date indicated on the license card.

# New Sidewalk Shed Maintenance Requirements

#### Dedicated to Safety

To ensure that sidewalk sheds are maintained safely over the course of a job, the Department is now requiring (49 kb-pdf) building owners or contractors to be responsible for their upkeep. The sidewalk shed company hired by the building owner will still obtain the permits to install the shed, but now the owner or contractor must be listed on the <u>PW2</u> as the applicant of record.

## New Annual Inspection Cycle for Boilers Starting Soon

On January 1, 2009, a <u>new annual inspection cycle</u> (46 kb-pdf) for boilers will become effective. To accommodate the change and the new cycle, the inspection cycle has been shortened in 2009.

# **Reminders**

## **New Insurance Requirements for Contractors**

Information You Need To Know

All contractors conducting business with the Department must <u>submit or update their insurance</u> (33 kb-pdf) with the <u>Licensing unit</u> by October 31. Those failing to meet this deadline will not be issued permits until they satisfy this requirement.

## **General Contractor Registration**

Information You Need To Kno



Contractors seeking to build one-, two- and three-family homes must <u>register</u> (31 kb-pdf) with the Department by October 31 to obtain a New Building permit. This includes general contractors who already have a tracking number with the Department.

# **Did You Know?**



Did you know that the Department has an in-house training academy where employees can pursue advance training and continuing education credits? At <u>Buildings University</u>, employees can participate in specialized trainings for inspector certifications that include Qualified Elevator Inspector (QEI) and National Association of Amusement Ride Safety (NAARSO), maintain Continuing Education Units (CEU) and advance their knowledge with intensive monthly trainings on the Building Code and Zoning Resolution.
