## **No-Penalty Retaining Wall Inspection Program**



On Wednesday, March 25, 2009, Buildings Commissioner Robert LiMandri <u>launched</u> the Department's annual <u>No-Penalty Retaining Wall Inspection Program</u>. Under this program, homeowners may call 3-1-1 to request an inspection of their retaining walls by a Buildings Inspector without penalty of violation. This program will be offered through June 1, 2009. As temperatures rise and the seasons change, retaining walls can become particularly susceptible to deterioration which can put nearby buildings at risk. ## **Commissioner Testifies Before OSHA**



Buildings Commissioner Robert LiMandri testified before the U.S. Occupational Safety and Health Administration (OSHA) in Washington D.C. on Wednesday, March 18, 2009, addressing proposed crane regulations that would rely on the industry's self-regulation. The proposed rules would deregulate the approximately 35 tower cranes and 250 mobile cranes that operate on New York City's streets each day by precluding Buildings Inspectors from

enforcing crane safety regulations on job sites. Crane regulation enforcement would fall to OSHA, which has no full-time staff dedicated to construction inspections in New York City. Following the two fatal crane accidents in New York City last year, Buildings enacted significant reforms to its oversight and regulation of cranes in New York City. These reforms would be preempted if the federal regulations are adopted in their current form.

## Required Items Now Accepted Electronically



The Department now allows applicants to submit <u>certain</u>
<u>required items</u> electronically through a new on-line submission
system known as eSubmit. Using an <u>eFiling</u> account, eSubmit

provides applicants the opportunity to upload certain required items and supporting documents from home or the office instead of a borough office. We have a created an eSubmit User <u>guide</u> to assist you with this new feature.

## **Emergency Work Guidelines**

#### Dedicated to Safety

When an emergency or hazardous condition necessitates immediate attention to protect the public or workers, Licensed Master Plumbers, Fire Suppression Piping contractors and Oil Burner Installer contractors may repair the condition and then file a Limited Alteration Application (<u>LAA1</u>) for the work. The Department has established Emergency Work <u>guidelines</u> to ensure the proper steps are taken when performing emergency work.

## **Multiple Dwelling Law Provisions**

Information You Need To Know

The Department has issued <u>Buildings Bulletin 2009-002</u> to clarify the Department's authority to waive or modify prescriptive provisions of the Multiple Dwelling Law (MDL) or import definitions of terms such as "height" and "story" from the building code into the MDL.

## **New Regulations for Façade Inspections**

Information You Need To Know

Amended Rule 32-03 related to the periodic inspection of exterior walls and appurtenances of buildings greater than six stories in height becomes effective March 27, 2009. There are several new key provisions in this rule, including the creation of staggered inspection cycles, new inspection deadlines, enhanced reporting requirements, notice of further penalties and filing fees and a new late filing penalty of \$250 per month.

## **New Fire Code Requirements**

#### Dedicated to Safety

FC 503.8.2 of the new Fire Code requires any new building located on a public street with a curb-to-curb width less than 38 feet to be protected throughout by a sprinkler system. Although existing buildings are generally exempt from compliance with this requirement, existing buildings that undergo "alteration" or a "change in use or occupancy" on or after July 1, 2008 may have to comply with this requirement. The Fire Department recently issued interimguidelines (See Question #3 of Chapter 5) to further define the types of alterations and changes in use or occupancy that are subject to FC 503.8.2. These will also be the subjects of future FDNY rulemaking. Until the issuance of such rules, the Department of Buildings will apply the interimguidelines for alteration applications.

#### Class C HMO Licenses

Information You Need To Know

Individuals seeking to maintain a <u>Class C Hoist Machine Operator License</u> must provide <u>documentation</u> of certification from the National Commission for the Certification of Crane Operators (<u>NCCCO</u>) by September 30, 2009. ## **New Safety Registration Numbers**

Dedicated to Safety

Beginning October 1, 2009, individuals and organizations performing or supervising certain construction projects, including new building and demolition jobs, will be required to have a new <a href="Safety Registration Number">Safety Registration Number</a>. The Department will begin accepting applications for Safety Registration Numbers in Spring 2009.

#### **Revised B-SCAN Enhancement**



To ensure Buildings Department documents remain accessible, on March 16, 2009 we <u>enhanced</u> the Department's B-SCAN system to scan, capture and electronically store approved building plans. Effective March 23, 2009, all building plans must conform to specific

guidelines or the plans will not be approved.
