

EFFECTIVE OCTOBER 15, 2012, THE ROBERT N. DAVOREN CENTER WILL IMPLEMENT A TEMPORARY CELL RESTRICTION POLICY FOR ADOLESCENT INMATES ONLY.

FAMILIES AND FRIENDS to Notice **OF ADOLESCENT INMATES (16-18 YEARS OLD)**

- AN ADOLESCENT MAY BE PLACED IN HIS CELL FOR UP TO TWO HOURS TO REGAIN HIS COMPOSURE AND PREVENT ESCALATING AN INCIDENT IF HE CONTINUES TO ENGAGE IN MINOR MISCONDUCT AFTER A STAFF MEMBER'S DIRECT ORDER TO STOP.
- ADOLESCENTS WILL NOT HAVE ACCESS TO THE PHONES OR DAYROOM DURING THIS TIME.
- ACCESS TO RECREATION, RELIGIOUS SERVICES, LAW LIBRARY, AND SHOWERS MAY BE DELAYED OR DENIED DURING THE TEMPORARY CELL RESTRICTION. AN ADOLESCENT ON TEMPORARY CELL RESTRICTION MUST DEMONSTRATE THAT HE HAS REGAINED HIS COMPOSURE AND IS WILLING TO COMPLY WITH DOC POLICIES AND PROCEDURES IN ORDER TO LIFT THE TEMPORARY CELL RESTRICTION.
- ACCESS TO COMMISSARY MAY BE DENIED DURING THE TEMPORARY CELL RESTRICTION. UNDER SUCH CIRCUMSTANCES, ADOLESCENTS WITH FUNDS IN THEIR ACCOUNTS WILL BE AFFORDED COMMISSARY THROUGH THE BAGGING OPERATION.
- VISITS WITH FAMILY AND FRIENDS, ATTORNEY VISITS, SCHOOL, SICK CALL AND MEDICATION WILL BE PROVIDED AS SCHEDULED DURING THE TEMPORARY CELL RESTRICTION IN ACCORDANCE WITH DOC POLICY.
- AN ADOLESCENT CAN AVOID RECEIVING ONE OR MORE INFRACTIONS AND BEING PLACED IN PUNITIVE SEGREGATION FOR THE CONDUCT RESULTING IN THE TEMPORARY CELL RESTRICTION IF HE COMPLIES WITH THE TERMS OF THE TEMPORARY CELL RESTRICTION.
- AN ADOLESCENT HAS THE RIGHT TO REFUSE THE TEMPORARY CELL ASSIGNMENT OPTION; HOWEVER, HE MAY BE INFRACTED, TRIGGERING THE FORMAL DISCIPLINARY PROCESS.
