<p style="text-align: center;">Job Description</p> <p>The New York City Department of Correction is seeking to recruit Staff Physicians to fill vacancies that may be available throughout the year. The successful candidates will provide employee medical services and support at the Health Management Division. Under executive direction and with latitude to exercise independent judgment, the incumbent will review medical fitness for duty of departmental employees requesting or returning from major leaves of absences for medical reasons, or of employees reporting sick. The candidate will also make determinations as to employees' fitness for duty; offer recommendations on care and treatment; order appropriate diagnostic tests; formulate diagnoses; direct or perform appropriate therapeutic treatment; provide medical counsel to employees; review employees medical documentation from private physicians; review all labs and x-ray reports for employees under his/her care on a timely basis; make medical management decisions appropriately; serve as a consultant to physicians in the field of specialty; and perform related duties as assigned.</p>	
<p style="text-align: center;">Minimum Qualification Requirements</p> <p>Possession of a valid license to practice medicine in the State of New York; and either:</p> <p>a) Valid Board Certification issued by the appropriate American Specialty Board in any specialty area required by the agency; or</p> <p>b) Current approved application on file for admission to the certifying examination given by the appropriate American Specialty Board in any specialty area required by the agency.</p>	
<p>Special Notes:</p> <p>To be assigned to Assignment Level II, individuals must have, in addition to meeting the minimum qualification requirements for Assignment Level I described above, one year of satisfactory experience practicing in the specialty area.</p>	
<p style="text-align: center;">Preferred Skills</p> <p>Ability to establish and maintain effective working relationships with all levels of correctional staff; Ability to exercise independent judgment, prepare written reports and documents; Excellent writing, communication, inter-personal, and organizational skills.</p>

However, City Employees in certain titles who have worked for the City for 2 continuous years may also be eligible to reside in Nassau, Suffolk, Putnam, Westchester, Rockland, or Orange County.
