<p>The New York City Department of Correction is seeking a Machinist (Tailoring.) Under supervision, the qualified candidate will repair all sewing machines: juki machine, con sew machine, yamato rimoldi machine, singer machine, wilcox and gibbs machine, union special machine, overlook machine, hemming machine, straight sewing machine, buttonhole machine and cloth spreading machine; also all cutting machines; maintain records and inventories of supplies and materials; and perform related duties as assigned.</p>	
<b>Minimum Qualification Requirements</b>	
<p>1. Five years of full-time satisfactory experience acquired within the last fifteen years as a machinist; or</p> <p>2. At least two and one-half years of full-time satisfactory experience acquired within the last ten years as a machinist plus sufficient full-time experience as a machinist helper or an apprentice machinist, or training of a relevant nature acquired in an approved trade, technical or vocational high school, to make up the equivalent of the remaining required experience. Six months of acceptable experience will be credited for each year of helper or apprentice experience or approved trade or vocational high school, up to a maximum of two and one-half years.</p>	
<b>Residency Requirement</b>	
<p>New York City residency is generally required within 90 days of appointment. However, City Employees in certain titles who have worked for the City for 2 continuous years may also be eligible to reside in Nassau, Suffolk, Putnam, Westchester, Rockland, or Orange County.
