Fire Protection Safety Standards

Listed below are some of the more important fire safety regulations that all camps must comply with. For a complete listing of fire safety regulations, camps can refer to New York City Health Code Article 48 by visiting the ‘Summer Camp’ web page at www.NYC.gov/Health.

- NYCHC 48.15 (a) (1) The camp director shall be responsible for the regular inspection of all fire protection facilities and equipment of the camp.
- NYCHC 48.15 (a) (3) Fire extinguishers and other suitable fire fighting equipment shall be placed at strategic and easily accessible points.
- NYCHC 48.15 (a) (5) Fire drills shall be held within the first 48 hours of each camping session and periodically thereafter in accordance with the fire safety plan. A log with drill dates and times must be maintained and verified by the camp director. It must be available for inspection at all times.
- NYCHC 48.15 (a) (6) The means of egress from all structures shall be maintained in an unobstructed, easily traveled condition at all times, and protected from hazardous areas such as heating plant, kitchen and inflammable storage.
- NYCHC 48.15 (a) (8) Fire extinguishers and other fire fighting equipment acceptable to the Department shall be provided, inspected and tagged by the camp operator prior to the camp season. The equipment shall be maintained in operating condition at all times.
- NYCHC 48.15 (a) (16) Emergency lighting shall be provided for halls, stairways and exit signs where required by the Department.
