## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU"), dated as of August 29, 2012, shall confirm an understanding between the New York City Department of Parks & Recreation ("DPR") and the New York City Department of Transportation ("DOT") concerning the establishment and/or maintenance of certain property currently or in the future to be identified as Bike Share sites in the City of New York.

## WITNESSETH

WHEREAS, DOT and DPR have compiled a comprehensive list of Bike Share sites, which is attached hereto as Exhibit A (collectively, "the Sites");

NOW THEREFORE, in consideration of the benefits to the public, each of the parties to this MOU agrees as follows:

- 1. This agreement shall be for a term of six (6) years, commencing on the day and year first above written. This agreement may be renewed for two (2) additional five (5) year terms by the written mutual consent of the parties, which consent shall not be unreasonably withheld.
- 2. DOT and DPR acknowledge that the Sites are temporary and will always remain as DPR jurisdictional properties, available for DPR purposes and uses as needed.
- 3. Any change or modification that would alter an individual or group of Sites' status as a Bike Share site, or any increase or decrease of the number of Bike Share sites, shall be effectuated by amendment to this agreement, which merely revises Exhibit A to reflect any increase or decrease in the number of Bike Share sites, or adds or subtracts a specific Site(s) and indicates the Site's location.
- 4. DOT and/or its agents will provide for regular trash removal and will be responsible for snow removal for the interior and six (6) feet in all directions from the exterior of the stations.
- 5. All contractors hired to perform work at the Sites shall be required to indemnify and hold the City harmless in relation to the work performed at the Sites. In addition, all contractors will be required to provide insurance in conformance with standard insurance protocols acceptable to the City.
- 6. This MOU shall be terminable in whole or in part, by the Commissioner of DPR in his or her sole discretion, upon twenty-five (25) days written notice to DOT by DPR. Notwithstanding the proceeding and prior to such written notice, DPR shall endeavor to

resolve any issue with DOT that would, if left unresolved, lead to DPR terminating this agreement.

- 7. Upon termination of this MOU and/or amendment thereof which excludes the use of a particular Bike Share site, DOT and/or its agents will make reasonable efforts to restore the Site(s) to the condition existing prior to the transformation of the Site(s) to Bike Share sites and in compliance with the New York City Administrative Code or, at DPR's option, DOT and/or its agents shall return the Site(s) in its current condition at the time of the request.
- 8. All notices between the parties shall be in writing sent by certified mail, return receipt requested, or personally delivered.

Any change of address shall be designated by written notice to the other party.

- 9. This MOU may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed original, but all such counterparts together shall constitute but one and the same instrument.
- 10. This MOU shall be binding upon and for the benefit of the parties hereto and each of their respective successors and permitted assigns. The provisions of the MOU shall be solely for the benefit of the parties hereto and no other person or entity shall be a third party beneficiary hereof.
- 11. This MOU may not be modified or amended except by written agreements executed by each Party hereto.
- 12. This MOU and the attachments hereto contain all the terms and conditions agreed upon by the Parties hereto, and no other agreement, oral or otherwise, regarding the subject matter of this MOU shall be deemed to bind any of the Parties hereto or to vary any of the terms contained herein.

- 13. If DPR reasonably objects to the sponsorship panel on the station kiosk on any of the structures placed on DPR jurisdictional property, DPR shall advise DOT of such objection(s) and DPR and DOT will reasonably discuss such objection(s). After such discussions, if DPR is not reasonably satisfied, DOT will undertake appropriate measures to address DPR's objection(s).
- 14. Except in the case of an emergency, DPR will seek to provide DOT with at least thirty (30) days notice if a Bike Share site needs to be temporarily moved to accommodate a DPR permitted event.
