

## Temporary Pedestrian Streets (a.k.a. “Weekend Walks”) Request for Expressions of Interest

In keeping with Mayor Bloomberg’s PlaNYC goal of expanding the amount of open space available to New Yorkers and consistent with our commitment to creating world-class streets and a more attractive public realm, the New York City Department of Transportation seeks to expand its temporary pedestrian street program in 2010.

If you are interested in organizing and hosting a pedestrian street in your neighborhood, please complete the following form. Doing so does not bind you or your organization to any particular proposal for any particular date, but will mark the starting point in a dialogue with NYC DOT to develop a successful plan.



### Background

Over the last two years DOT assisted businesses and community groups in all five boroughs to host temporary pedestrian streets, by closing streets to motor vehicles on weekend days and opening them to people and local businesses. DOT has identified good practices and guiding principles that we will use to select new sites and assist with the development of new temporary pedestrian streets.

The Temporary Pedestrian Street program is a community-based initiative. If your site is selected, DOT will assist with securing a street closure and provide technical assistance to navigate relevant City permitting processes. DOT does not provide an event planner for these events. It is DOT’s intention that these events will be conceived of, planned, organized and executed by BIDs, local merchants associations and/or community-based groups.

## Guiding Principles

### What a Temporary Pedestrian Street is:

- Multi-day\*
  - Picking regularly recurring dates (e.g. every Sunday in July, or every Saturday throughout the Summer) creates a regular public space, which is the aim of the program
- Led or co-sponsored by local merchants association, Business Improvement District or civic group, with a general local consensus in favor of the plan
- Promotes and engages local businesses and organizations
- Held in an area such as a commercial main street or another area that connects sites frequented by pedestrians, where existing uses and activities could be positively enhanced by more space for walking and outdoor activity and the temporary suspension of motor vehicle access.



### What a Temporary Pedestrian Street is not:

- A street fair (i.e. no vending in the streets by commercial interests from outside the community) \*\*
- A block party (i.e. a one-day / one-block event)
- A race or other sporting event requiring public participants to pre-register
- A parade that fills the space vacated by motor traffic
- An initiative that results from a battle of competing local interests

### What Works:

- Building support in merchant and residential communities
- Engaging local merchants, community-based organizations, artists and musicians to provide programming
- Marketing the event
- Meeting regularly with your partners and NYC DOT to refine the event
