Re: Adult Literacy Services/Young Adult Literacy Services

Request for Proposals PIN: 26012ALITRFP

Dear Prospective Proposer:

 Pursuant to Sections 3-02 (i) and 3-03 (f) (2) of the Procurement Policy Board (PPB) Rules, the Department of Youth and Community Development (DYCD) is issuing Addendum #1 to the Adult Literacy Services/Young Adult Literacy Services Request for Proposals (RFP) PIN 26012ATRFP.

ADDENDUM ITEMS

1. Section II, Summary of the Request for Proposals, page 6, C, Service Options/Competitions: The following has been added to the end of the section:

The funds for direct instructional services under this RFP are intended to support community-based organizations' adult literacy and young adult literacy services. Government entities and their affiliates, including but not limited to the City's public library systems, the Department of Education, the City University of New York, the State University of New York, and other City agencies are not eligible to receive contract awards under Service Option I, Competitions 1 and 2 and Service Option II, Competition 1.

2. Section II, Summary of the Request for Proposals, page 6, D, Anticipated Maximum Available Annual Funding: After the first sentence of the second paragraph the following sentence has been added:

The \$50,000 allocated to the internship component is intended to cover both the internship stipends and the administrative costs. The expectation is that approximately half (\$25,000) would pay for stipend costs and the balance for an experienced staff person who would coordinate the internship component.

- 3. Section III, Scope of Services, page 11, B2, Service Option I and Service Option II, Competition 1: The second bullet
 - The contractor's internal monitoring system would be effectively used to identify program, personnel, and fiscal issues and provide corrective action procedures.

is deleted and replaced with the following:

The contractor's internal monitoring system would be effectively used to identify personnel and fiscal issues and provide corrective action procedures.

- **4. Section III, Scope of Services, page 14, C1d3), Provision of Instruction:** The beginning of the first bulleted point:
 - optimize literacy and language gains by providing opportunities to practice literacy skills as frequently as possible by offering classes that meet at least four times per week and for at least ten hours per week. Each class <u>must</u> meet a minimum of six hours per week; each program would provide a minimum of 150 hours of classroom instruction annually per student.

is deleted and replaced by the following:

- Each class <u>must</u> meet a minimum of six hours per week. However, to optimize literacy and language gains by providing opportunities to practice literacy skills as frequently as possible, DYCD recommends that each class meet at least four times per week and for at least ten hours per week. Each program would provide a minimum of 150 hours of classroom instruction annually per student.
- 5. Section III, Scope of Services, page 16, C1d6)i), Outcomes, Data Collection, and Reporting: The second sentence:

For Core Indicator 1, contractors would be expected to meet or exceed the minimum achievement standards set by the NRS.

is deleted and replaced with the following:

For Core Indicator 1 only, contractors would be expected to meet or exceed the minimum achievement standards. Contractors would not be evaluated on meeting the achievement standards for Core Indicators 2 and 3.

6. Section III, Scope of Services, page 21, C2d3), Internship Experience: After the third bulleted item the following has been added:

The contractor would also complete the following required activities:

- 7. Section IV, Format and Content of the Proposal, page 26, A3a1), Service Option I and Service Option II, Competition 1: The last item under the third bulleted item:
 - achieving placement of youth in internships and community service projects (target levels vs. actual levels)

is deleted and replaced with the following:

- for Service Option II, Competition 1, achieving placement of youth in internships and community service projects (target levels vs. actual levels)
- 8. Section IV, Format and Content of the Proposal, page 27, A3b1), All Competitions: The second bulleted item:
 - Demonstrate successful joint efforts with other organizations and agencies providing the proposed program services.

is deleted and replaced with the following:

- Demonstrate successful joint efforts with other organizations and agencies providing literacy or related services.
- 9. Section IV, Format and Content of the Proposal, page 29, A3c1)iv): Program Design: the first bulleted item:
 - outreach and recruitment

is deleted.

10. Section IV, Format and Content of the Proposal, page 30, A3c1)vii): Partnerships, Collaborations, and Linkages: The second sentence of the first item under the first bulleted item:

Demonstrate that the contractor would coordinate referral and intake procedures with RAEN.

is deleted.

- 11. Section IV, Format and Content of the Proposal, page 32, A3c2)iii)g): Other Educational Services: The following bulleted item is added:
 - Describe linkages with community organizations, government agencies, education providers, and other service providers which will help participants achieve outcomes through supportive services not directly provided by the program. Complete a Linkage Agreement Form (Attachment 7) for each linkage described.

12. Section IV, Format and Content of the Proposal, page 35, A4a1): Annual Budget Worksheet (Attachment 8): The following sentence is added:

The Annual Budget Worksheet applies to DYCD funding only.

13. Section IV, Format and Content of the Proposal, page 37, B1: The first sentence:

The Proposal package should include **one original set and** <u>eight</u> <u>duplicate sets</u> of the documents listed below in the following order:
