MEMORANDUM OF UNDERSTANDING

BETWEEN THE NEW YORK CITY FIRE DEPARTMENT AND _____

This memorandum provides the procedures to follow in order to obtain a **Consolidated Certificate of Fitness for Use of LPG in Heating Devices, Emergency Repairs, Mobile Units, Street Repairs, and Traffic Lines (G -96)** without a written test administered by the New York City Fire Department. However, applicants may take advantage of this policy only when the administration of a written exam is not practicable. Applications for alternative issuance must be submitted **by mail only**.

1. SUBMIT NOTARIZED STATEMENTS

A notarized statement from the premises manager or building owner stating that the applicant has a reasonable understanding of and has received training in 3RCNY §25-02, 03, 05, 08,10, and 14. The statement must include the applicant's full name, character, physical condition, experience, and address of the premises where applicant will be employed. This statement must be submitted on Company's official letterhead.

B) A notarized statement from the applicant stating that he/she is being issued a Certificate of Fitness by the Fire Department, on the basis of his/her experience, education, and understanding of the rules and regulations regarding the use of LPG in heating devices, emergency repairs, mobile units, street repairs and the marking of traffic lines. The statement must include the applicant's full name, experience, and address of premises where applicant will be employed.

2. COMPLETE FORM A-20

All applicants must complete a Certificate of Fitness Application (Form A-20).

3. APPLICATION FEES

A check or money order for \$25.00 must accompany each application.

4. PHOTOS

All applicants must submit a recent 2x2-color photo

5. SPECIAL QUALIFICATIONS

Individuals holding a license as a Professional Engineer (PE) or Registered Architect (RA) issued by the NYS Dept. of Education plus one year of fire protection or fire safety experience may apply for alternative issuance

6. ADDITIONAL INFORMATION

All applicants must submit proof of education, training, diplomas, certificates, licenses, etc.

All applicants wishing to renew their Certificate of Fitness must submit a notarized statement attesting to their knowledge and understanding of amendments to 3RCNY §25-02, 03, 05,

08, 10, and 14 prior to submission of Certificate of Fitness renewal.

Applicants who have failed the written exam will not be allowed to take advantage of this policy. **Qualified applicants must submit all documentation by mail.**
