#### 2.3 SUBMISSION OF BISP FORM A134-P AND BIN ENTRIES

It is essential that inspections of buildings under Construction, Demolition and Abatement be recorded and tracked accurately in the BISP Intranet application. The Building Identification Number (BIN) is the primary identifier of these buildings. All A134-P's submitted via the BISP Intranet application must contain an accurate BIN. Accurate BIN's can be found at the following locations on the FDNY Intranet:

- The corresponding BIN that is contained within the CDA database.
- The BIN search available on the "FDNY Building Information Search" for buildings not in the CDA database.

**Note:** The generic BIN of "9999999" is no longer allowed to be entered on the A134-P.

If a valid BIN cannot be located via the above methods, Chief and Company Officers may e-mail Captain Brian Byrne, Bureau of Operations at [byrneb@fdny.nyc.gov](mailto:byrneb@fdny.nyc.gov). Do **not** use the use the BIN available on the NYC Department of Building website for entries on an A134-P.
