2.4 HAZ-MAT DECON SUPPORT UNIT – NEW LOCATION

The Haz-Mat Decon Support Unit previously assigned to Rescue Operations on Roosevelt Island has been reassigned to Haz-Mat Operations and is now located at 104-32 43 Avenue, Corona, Queens. The unit responds to all hazardous materials incidents where decontamination is required. The DSU is responsible for the collection, tracking and decontamination of equipment as well as providing logistical support and technical expertise. 2.5 JOHN JAY COLLEGE TUITION REIMBURSEMENT
