# 2.1 RISKED BASED INSPECTIONAL SYSTEM (RBIS)

The Bureau of Training is continuing RBIS training for Chief and Company Officers, Division by Division. As each Division completes RBIS training, they will begin using the RBIS application. Currently, Division 6 and 7 are using RBIS. <u>Effective Monday</u>, 0900 hours, <u>December 31</u>, 2012, <u>Division 1 will begin using the RBIS</u> application as the system of record.

Companies issued ice and cold water rescue equipment are reminded to comply with Equipment Care and Maintenance outlined in section 9 of Emergency Procedures, Water Rescue 2, Section 9.2, which states:

All ice and cold water equipment shall be inspected during January, April, July and October.
