2.4 NEW BUNKER GEAR

All FDNY bunker gear manufactured by Honeywell after July 1st, 2016, has been redesigned with several distinct changes intended to increase mobility and functionality. In order to improve the garment cleaning process and reduce the possibility of cross-contamination, the bunker coat and pants now have a removable thermal liner. The liner can only be separated from the outer shell by a certified bunker gear cleaner. **Under no circumstances shall bunker gear be worn without the thermal liner.** Chief and Company Officers shall ensure all members comply with this directive.

2.5 CFR CERTIFICATION AND ELIGIBILITY

Department members, who have taken the NYS CFR exam in September 15, 2016 and have received a passing grade, are eligible to perform CFR duties effective 0900 hours, October 4, 2016.

They shall immediately provide a copy of their certificate and/or test results to their Company Commander. Company Commanders upon receiving a copy of the member's NYS CFR certificate shall record particulars in the Office Record Journal as per CFR Manual, Chapter 1, Section 5.1. A copy of the certificate shall be placed in the member's personnel folder. The CFR Training unit (718) 281-8469 shall be immediately notified any time a member fails the NYS CFR exam. The CFR Training unit will provide information regarding retaking the NYS exam.
