**AMENDMENTS TO FD MANUALS**

**2.1.1 AUC 207**

AUC 207, titled *Subway and Railroad Track Operations* dated March 15, 1997, is **amended** as follows:

Under Section 3.2.4 **Add:** New Note, to read:

**Note:** The power removal box should be used with the utmost discretion, as its use can cause wide ranging effects e.g., stranding trains with passengers in tunnels. In addition, anytime power is removed by use of a power removal box, the IC shall forward a letterhead report with full particulars through the chain of command to the Chief of Operations.
