2.3 REMINDER – BHS POSTPONEMENTS

- 3.3 A postponement will be for a limited period. Members granted a postponement shall notify the Nursing Staff at the Bureau of Health Services (718) 999-1918 if they become ambulatory during that period.
- 3.4 The Clinic Officer will grant postponements for non-medical reasons on a case-by-case basis.
