2.4 2021 FISCAL YEAR CALCULATION BEGINS JULY 1, 2020

Fiscal Year 2021 begins 07/01/2020. Payrolls will be calculated on a non-leap year basis commencing with pay periods covering any day falling on or after 07/01/2020. This means that any calculations utilizing 366 days as part of the formula for the Fiscal Leap Year ending 06/30/2020, will be changed to use 365 days as part of the calculation effective 07/01/2020. Bi-weekly paychecks beginning on 07/10/2020 will be prorated. This change in calculation during the fiscal year will result in a small increase in gross pay.

2.5 REOPENING OF THE EDENRED COMMUTER BENEFITS WALK-IN CENTER

The Edenred Commuter Benefits Walk-In Center has re-opened at 450 Seventh Ave., Floor 19, Room 1906, New York, NY 10123 (Between 34th and 35th Streets) for the replacement of Annual Transit Cards only. Edenred prepared the following guidance for reopening the center safely:

- Visitors are required to wear a face mask or face covering in all common areas of the facility.
- Entrance doors will be open during peak entry periods to provide a touchless entry.
- See-through protective screens have been installed at each manned station for keeping social distancing.
- All public areas have been cleaned and disinfected in strict adherence with the CDC guidelines and product recommendations.

The business hours for the Edenred commuter Benefits Walk-In Center are from 8:00am to 4:00pm, Monday through Friday, participants seeking a replacement Annual Transit Card must bring a valid photo identification card. Replacements for Annual Transit Cards may continue to be ordered online www.commuterbenefitsnyc.com or by phone at 1-833-584-8109. You will have the option to have the replacement card mailed to your commuter benefit address on file or have it ready for pick up at the Edenred Commuter Benefits Walk-In Center.
