REMINDER - POSTING OF SH-900.1

Officers are reminded to comply with procedures outlined in Safety Bulletin 7, Addendum 1 titled NYS Dept. of Labor Log, SH-900 and Summary of Occupational Injuries and Illnesses, SH-900.1; which states in part:

In February, each unit shall post the SH-900.1 Summary report. Using the date range of the previous year, print a copy of the report. From February 1st to April 30th the Summary SH-900.1 of all injuries and illnesses for the previous year must be posted on a notice board accessible to all employees. Failure to comply with the above requirements is a violation of New York State law and may result in appropriate enforcement action by the New York State Department of Labor.
