2.2 REQUEST TO REVIEW 2021 LODI

Any member with a dispute of 2021 medical leave dates on your 2021 W2 may request an inquiry by going to the FDNY Intranet Home Page, Click Forms - Fire Admin Forms - [Request to Review 2021 LODI](#) and [Request to Review 2021 LODI Form](#) and email to 2021LODIInquiry@fdny.nyc.gov as we are unable to accept telephone inquiries. The Bureau of Health Services (BHS) will review your entire 2021 medical leave dates in question; a decision will be rendered after review of ALL medical leave dates submitted for 2021. At the conclusion of the inquiry, if verified that an adjustment (positive or negative) must be made, a request for an Amended W2C will be requested on your behalf to adjust any/all discrepancies. You will receive a letter from BHS to the decision of your inquiry and you will receive your amended W2C from the City to your place of residence which will take a few weeks. You must submit all information on the LODI Form. The cutoff for the 2021 Tax season is December 18, 2021; any medical leave that carries beyond this date will be reflected in the 2022 W2. Members are advised to read both LODI documents before submitting a request for a review.

2.3 UNUSUAL OCCURRENCE REPORTS - REMINDER

Members are reminded to comply with Regulations Sections 30.1.6 & 30.8.4, which state in part: Letterhead report, for an unusual occurrence, containing a detailed description of the incident shall be forwarded to the Chief of Operations through the chain of command. In addition, reports of special importance, shall be preceded by an immediate telephone communication to the Deputy and Battalion Chief on duty.
