Vehicles Allowed: \*Dead Road or Cherry Hill Area. Dead Road runs north & south along eastern length of the Sheep Meadow, and west of the Bandshell. \*Access: At 5 Ave, take 72nd St drive west, passing Bethesda, enter at the southside opening of wooden guardrail to the asphalt path leading to Dead Road, parking ONLY on one side, as determined by 1st arrival.
