# • LL84 – Benchmarking Public Disclosure in Fall 2013

- In September, the City will publicly disclose metrics reported in the third year of benchmarking for all covered properties. These metrics include the ENERGY STAR score, energy use intensity, water use, and greenhouse gas emissions.
- Certain properties may be eligible to have their ENERGY STAR scores withheld from disclosure if at least 10% of their properties' gross floor area is a trading floor, TV studio, or data center. Once Portfolio Manager is re-launched next week, further guidance will be posted about the proper procedure to request exemption.

# • LL84 – Request Exemption from ENERGY STAR Score Disclosure by August 1

- In September, the City will publicly disclose metrics reported in the third year of benchmarking for all covered properties. These metrics include the ENERGY STAR score, energy use intensity, water use, and greenhouse gas emissions.
- Certain properties may be eligible to have their ENERGY STAR scores withheld from disclosure if at least 10% of the property's gross floor area is a trading floor, TV studio, or data center. If you qualify to have your ENERGY STAR score withheld, you must alert the City. To verify that your property is eligible, please email <a href="mailto:GGBPDigest@cityhall.nyc.gov">GGBPDigest@cityhall.nyc.gov</a> and provide the floor area of the trading floor, TV studio, or data center, and the total gross floor area of the property. These requests must be received by August 1.

# LL84 – Revised Guidance for the Revised Portfolio Manager

- o Revised guidance for "First Time Benchmarking," "Benchmarking Refresher," and "How to Submit to the City" has been posted online at <u>LL84: How to Comply</u>.
- At this time, automatic uploading of water through Portfolio Manager's Web Services, formerly known as "Automatic Benchmarking Services," is unavailable.
   The City encourages those properties required to report their water usage to manually enter their data. Revised guidance on water benchmarking has been posted at <u>LL84</u>: Energy and Water Data Collection.

# • LL84 –Exemption Requests from ENERGY STAR Score Disclosure due TOMORROW, August 1

- In September 2013, the City will publicly disclose metrics reported in the third year
  of benchmarking for all covered properties. These metrics include the ENERGY
  STAR score, energy use intensity, water use, and greenhouse gas emissions.
- Certain properties may be eligible to have their ENERGY STAR scores withheld from disclosure if at least 10% of the property's gross floor area is a trading floor, TV studio, or data center. If you qualify to have your ENERGY STAR score withheld, you must alert the City. To verify that your property is eligible, please email GGBPDigest@cityhall.nyc.gov and provide:
  - The floor area of the trading floor, TV studio, or data center,
  - The total gross floor area of the property, and
  - The property's BBL, BIN, and street address
