REMINDERS

• LL84 – Portfolio Manager Being Upgraded

- EPA's Portfolio Manager, the online tool used to benchmark energy and water usage to comply with LL84, is undergoing a major overhaul. Portfolio Manager will be taken offline June 26 and will not be available through July 9 to complete the upgrade. During this time you will NOT have access to your account.
 - Read the <u>EPA's Frequently Asked Questions</u> about the upgrade.
 - Read the <u>Portfolio Manager Project Fact Sheet</u> to see more information on what to expect with the upgrade.
 - Although your saved data in your account will not change, some reporting metrics and features will change. Therefore EPA highly recommends that all account holders print out their "Statement of Energy Performance" prior to June 26th. Follow the easy instructions on the attached PDF document "Create a Statement of Energy Performance."
 - Some reporting features for Data Centers are changing. To see if your property type will be affected, please review the attached EPA reference PDF document, "Does your Data Center Meet the Portfolio Manager Definition?"
 - For those non-residential properties applying for ENERGY STAR certification, EPA reminds you that the application should be completed and submitted prior to June 26.

• LL84 – Second Reporting Deadline is August 1

Reminder that if you missed the extended first reporting deadline of May 31, the City is authorized to issue a violation and fine. You will **NOT** be able to submit your reports between June 26 and July 9 while Portfolio Manager is being upgraded.

 - Portfolio Manager will be taken offline TOMORROW, June 25 at 9PM and will not be available through July 9. During this time you will NOT have access to your account.
