• LL84 – Con Ed Aggregated Data Service is Currently Delayed

• We have been informed that Con Ed is currently delayed in sending out aggregated consumption reports. Please be patient as they work to turn around data requests.

- LL84 May 1 Compliance Deadline
 - Please remember to benchmark and submit to the City by the May 1, 2013 deadline.

• LL84 – Con Ed Aggregated Data Request

- If you are requesting on behalf of a building owner, the request must be accompanied by a letter of authorization (LOA) to Con Ed. In the LOA, the property owner must clearly indicate the location (service address) and account number that is being permitted. Previous years' LOAs may be used as long as all identifying information was included.
- Please verify that the account number is written correctly or the aggregate data request may not be processed. The account number should be for a common area associated with the service address, and written as 14 digits, no dashes.
- Please do not send multiple requests for the same service address; sending multiple requests for the same data may lead to duplicate invoices.
- Please make sure you have your requests in by **April 15** to allow ample time for processing.

• LL84 – National Grid Aggregated Data Request

 If you are requesting on behalf of a building owner, the request must be accompanied by a letter of authorization (LOA) to National Grid. In the LOA, the property owner must clearly indicate the location (service address) and account number that is being permitted. National Grid will not accept previous years' LOAs.

- LL84 Deadline for Con Ed Aggregated Data Request is Monday, April 15th for Receipt By May 1st
 - In order to receive your report by May 1st, please have your request emailed by April 15th and your payments made before April 24th.
 - To obtain aggregated consumption data please complete the <u>Aggregated</u> <u>Consumption Request form</u> and email it to <u>citybenchmarking@coned.com</u>.
 - If you are acting on behalf of a building owner please include all applicable letters of authorization with the initial request.
 - After receiving a request at <u>citybenchmarking@coned.com</u>, an invoice will be sent via e-mail to the customer who initiated the request.
 - Once the invoice has been paid, Con Edison will e-mail the aggregated consumption data in an Excel spreadsheet within **15 days** after the payment has been received.

 - The reporting link to submit your 2012 benchmarking data is also accessible at <u>LL84 How to</u> Comply.
 - Data used in Portfolio Manager Reports is updated nightly and the report will not reflect any changes you make to your account until the next day. Therefore final edits must be done by Tuesday, April 30th to submit your data for Wednesday, May 1st.

 - Once the invoice has been paid, Con Edison will e-mail the aggregated consumption data in an Excel spreadsheet within **15 days** after the payment has been received.

 - Data used in Portfolio Manager Reports is updated nightly and the report will not reflect any changes you make to your account until the next day. <u>Therefore final edits must be done by</u> <u>TOMORROW</u>, April 30th to submit your saved data for Wednesday, May 1st.
