FEMALE GENITAL CUTTING AND MUTILATION CONFERENCE

On Wednesday, April 27, 2011, Harlem Hospital Center and Sauti Yetu Center for African Women hosted a national conference on the delicate topic of Female Genital Cutting/Female Genital Mutilation. The conference theme, "Caring for families affected by FGC: Evidence to guide research, intervention and public policy" was held in the Herbert G. Cave Auditorium from 8:30 am to 5:00 pm. National and international experts, along with health care and social work providers discussed the background and overview of FGC, why and where the procedure is performed and the global efforts to end the practice. There were panel discussions on patient Clinical Encounters and Ethical Issues. Voices From the Community, Research and Data Collection, and Community Empowering Models.

Female Genital Cutting (FGC) involves partial or total removal of the external female genitalia, or other injury to the female genital organs for non-medical reasons. The practice is mostly carried out by traditional circumcisers, who often play other central roles in communities, such as attending childbirths. FGC is recognized internationally as a violation of the human rights of girls and women. Due to immigration, New York City hosts a large population of women from FGC-practicing countries, many

of whom seek OB/GYN care at Harlem Hospital Center. The conference was a collaboration of efforts by Harlem Hospital Center's Chief of OB/GYN, Dr. Edgar Mandeville and Zeinab Eyega, MSc. Executive Director and Founder of the Sauti Yetu Center for African Women. "This is an extremely important issue at it relates to Harlem Hospital Center's commitment to women's health and disseminating vital information to our patients and the community we serve", states Dr. Mandeville.
