

You Are Eligible For NCP/EITC If You:

- Are a New York State resident;
- Are at least 18 years old;
- Have a social security number that is valid for work (Individual Taxpayer Identification number cannot be used);
- Are the parent of a child who did not live with you and was under 18 on December 31 of the tax year;
- Were ordered to pay child support through the Office of Child Support Enforcement for at least ½ of the tax year;
- Paid 100% of the child support due for the tax year;
- Earned \$35,500 or less (tax year 2009); and
- Did not have more than \$3,100 in interest income (savings account, stocks, bonds, etc.).

All of the above must be true to qualify

HOW MUCH WILL THE NCP/EITC BE?

If you meet all of the requirements for the Noncustodial Parent EITC, the amount you get will be based on your adjusted gross income from your Federal tax return. The tax credit is the same no matter how many children you have. The following is to be used as a guideline for tax year 2009. In order to know exactly what your credit would be, fill out New York State tax Form IT-209 and file it with your New York State personal income tax return.

Adjusted Gross Income	EITC
\$3,000	\$578
\$6,000	\$1142
\$9,000	\$845 ●
\$12,000	\$609 ●
\$15,000	\$609 ●
\$18,000	\$558
\$21,000	\$461
\$24,000	\$366
\$27,000	\$270
\$30,000	\$174
\$33,000	\$78

- If you are married (to someone other than your child's custodial parent) and filing a joint tax return, your credit will be higher.

Example:

- *The noncustodial parent's adjusted gross income was \$21,000 last year.*
- *He has been ordered to pay \$265 per month in child support (based on 17% of his gross income minus Social Security, Medicare, and New York City taxes) for 1 child.*
- *If he paid \$3,180 in child support for the year (\$265 x 12 months) and meets all of the other requirements for the Noncustodial EITC, he would be eligible for a tax credit of \$461.*

HOW DO I APPLY FOR THE NCP/EITC?

You must file a State tax return, even if you did not earn enough money to require you to file a return. File Form IT-209, "Claim for Noncustodial Parent New York State Earned Income Credit," and attach it to your state tax return. You can still file retroactively back to tax year 2006. For more information on filing requirements see Form IT-209 I (Instructions for Form IT-209).

CAN I GET MORE THAN ONE NCP/EITC IF I HAVE ADDITIONAL CHILD SUPPORT CASES?

No. You can only receive one EITC, even if you have more than one case. But you have to meet the child support payment requirements on all of your cases in order to receive the credit.

HOW WILL I RECEIVE THE NCP/EITC?

If the amount of the credit is greater than the amount of New York State taxes that you owe, you will be entitled to a refund. However, if you owe back child support, the income tax credit will be used to reduce the arrears.

CAN I GET HELP FILING MY TAX RETURNS?



It Pays to Support Your Children

If you make less than \$35,500 a year, you could receive a tax credit on your 2009 New York State Income Tax Return. The Noncustodial Parent Earned Income Tax Credit, or NCP/EITC, helps parents who do not have custody of their children supplement their wages. You could be the "noncustodial" parent if you are not the main care giver for your children and you are making child support payments. The EITC is there to help you as a noncustodial parent.

WHAT IS THE NONCUSTODIAL PARENT/ EARNED INCOME TAX CREDIT?

The NCP/EITC is a New York State tax credit for low-to-moderate income individuals who do not have custody of their children to supplement their wages. The NCP/EITC can reduce what you owe in taxes, help you pay off back child support, and, in many cases, give money directly to you.
