

WHERE DO I APPLY FOR FOOD STAMP BENEFITS?

Applications can be filed in person at any Food Stamp office, or through an authorized representative. You may also mail or fax your application to any Food Stamp office within the five boroughs of NYC.

WHAT IF I DO NOT SPEAK ENGLISH?

Interpreter services are available.

WHAT ARE THE FOOD STAMP RESOURCE LIMITS?*

A household can have up to \$2,000 in resources. A household where at least one person is elderly (60 years or older) or disabled can have up to \$3,000.

* Beginning January 2008, the resource limits will change.

WHAT TYPE OF DOCUMENTATION WILL I NEED TO SHOW TO BE ELIGIBLE FOR FOOD STAMPS?

While no documentation proof is necessary to apply, you will eventually be asked to verify the information you present as part of the application process. Below is a list of documents which, if you provide right away, may help you get assistance sooner.

- **Proof of Identity:**
Photo ID, driver's license, passport, naturalization certificate, hospital/doctor's records, or adoption papers.
- **Proof of where you live:**
Statement from landlord/primary tenant, current rent receipt or lease, or mortgage records.
- **Proof of Income (if any):**
Current pay stubs, pay envelopes, business records, tax records, or current income tax return, etc.
- **Proof of Resources (if any):**
Current bank statements, stock/bonds records and insurance policy, etc.
- **Proof of Citizenship or Current Alien Status:**
Birth certificate, U.S. passport, USCIS documentation, military service records, etc.
Other documents may also be acceptable.

IF I DON'T HAVE ALL OF THE DOCUMENTS NOW, CAN I STILL APPLY FOR FOOD STAMPS?

Yes, you can still apply. When possible, Food Stamp office staff will provide assistance in obtaining the required documents.



These Food Stamp offices are open from 8:30 AM to 5:00 PM, Monday through Friday (except legal holidays).

FREQUENTLY ASKED QUESTIONS

WHAT ARE FOOD STAMPS?

Food Stamps are used "in place of cash" to provide your family with assistance when buying food. Their dollar value is on a 'swipe' card that you use just like a 'debit' card. Money is deducted when you buy food at grocery stores and supermarkets.

WHO CAN APPLY FOR FOOD STAMPS?

Any individual or any family who needs assistance in buying food can apply for Food Stamps.

WHO IS ELIGIBLE TO RECEIVE FOOD STAMP BENEFITS?

Many people are eligible and don't realize it. You can be employed and still be eligible for Food Stamps. You can own your own home and car and still be eligible for Food Stamps. Each application is evaluated on an individual basis.

HOW CAN I GET A FOOD STAMP APPLICATION FORM?

- Call HRA's Infoline at 1-718-557-1399.
- Pick one up from any Food Stamp office.
- Download an application from the Office of Temporary and Disability Assistance website: www.otda.state.ny.us/main/foodstamps/
- Go to the web address www.NYC.gov and click on ACCESS NYC for an application as well as eligibility prescreening.

IF I AM RECEIVING SSI/DISABILITY BENEFITS, DO I STILL QUALIFY FOR FOOD STAMP BENEFITS? WILL THEY REDUCE MY SSI/DISABILITY PAYMENTS?

Yes, you can still qualify for Food Stamp benefits even if you are in receipt of SSI/disability benefits as long as you meet the eligibility rules. Receipt of Food Stamps does not reduce your SSI/Disability payments.

HOW SOON AFTER I APPLY FOR FOOD STAMPS WILL I RECEIVE FOOD STAMP BENEFITS?

In general, if you are found eligible for Food Stamps, you will receive them within 30 days. In some cases, emergency benefits can be issued sooner.

WHERE DO I APPLY FOR FOOD STAMPS IF I AM HOMEBOUND?

If you are homebound, you can call the Food Stamp office that serves homebound individuals. The telephone number is (718) 722-4800.

HOW MUCH INCOME CAN I HAVE AND STILL BE ELIGIBLE FOR FOOD STAMPS?

The Food Stamp Income Guidelines as of October 2007 are as follows:

*If you or a member of your household is age 60 or more or is disabled, there is no Maximum Monthly Gross Income Test.

The amount of Food Stamp benefits you receive depends on your expenses and your income.
