New York, Sept. 22, 2011 – In a major speech to the Citizens Budget Commission this morning, Corporation Counsel Michael A. Cardozo discussed legal and financial issues affecting New York City and outlined key legal initiatives critical to the City's continued economic health, including highlighting glaring fixes needed to reform state tort laws.

The Corporation Counsel discussed suits brought by the New York City Law Department to enhance the City's revenue. For example, the Law Department collected \$125 million for the City in the past fiscal year by enforcing the City's contractual and statutory rights. Cardozo discussed specific cases, including the \$104 million verdict, now on appeal, won against Exxon-Mobil for allowing the gasoline additive MTBE to seep into the groundwater in Queens and suits brought to enforce city tax laws on cigarettes. Cardozo also described the Law Department's defense of the City's \$16.8 billion real estate tax base. Last year, the Law Department defended against tax claims seeking approximately \$300 million in refunds.

During his address, the Corporation Counsel also detailed the huge price the City pays for state tort laws that urgently need reform. He called on those in attendance, as well as elected officials and policymakers, to join the City in advocating for needed statutory changes. The City paid out \$561 million in suits in the past fiscal year. The Corporation Counsel noted, "In a time of financial crisis and budgetary cuts, \$561 million is not just a huge number – it represents an unacceptable tradeoff in favor of individual plaintiffs at the expense of providing needed services to New Yorkers."

Corporation Counsel Cardozo highlighted State tort laws that too often compensate plaintiffs for far more than the amount of the injury suffered:

- The requirement that the City pay damages even when the plaintiff's actions were the primary cause of the accident.
- Unlimited awards for pain and suffering that result in multi-million dollar verdicts.
- Unfair joint and several liability rules that hold the City responsible even when another defendant was primarily responsible.
- Anachronistic laws awarding an unheard of 9-percent interest on judgments.

Changing these laws would relieve municipalities across the state from a tort albatross that is in effect an unfunded State mandate, the Corp Counsel stressed.

In sum, Cardozo said, "We will continue our efforts both to collect money that is owed to the City, and resist efforts to make the City pay for unjustified claims."
