New York, March 28, 2011 – Corporation Counsel Michael A. Cardozo today proudly announced Candice Cho as the winner of the New York City Law Department's first-ever Corporation Counsel Clerkship. Ms. Cho was selected from over 400 applicants for the position.

In November 2011, Cardozo announced plans to initiate a one-year clerkship, funded by private donations, to be made available to recent law school graduates to work in the Corporation Counsel's Office. The Corporation Counsel Clerkship at the New York City Law Department—modeled on a traditional judicial clerkship—is allowing high-caliber junior attorneys to pursue an interest in legal issues relating to local government. The clerkship is the first of its kind for New York City.

"We had an extraordinarily competitive pool of applicants," noted Corporation Counsel Cardozo. "However, I cannot think of a better candidate than Candice Cho. She combines both a razor-sharp intellect with a strong and abiding interest in public affairs. We have no doubt she will make valuable contributions during her Law Department clerkship, and we look forward to watching her career and her interest in public service continue to soar. She represents all the brightest talents of those who will shape the City of tomorrow."

Ms. Cho echoed this excitement. "I am thrilled and honored to be selected for the inaugural Corporation Counsel Clerkship. 'Externing' for the Corporation Counsel's Office as a law student last year introduced me to some of the diverse and difficult legal issues facing the City—as well as the rewards of belonging to the team of lawyers dedicated to successfully meeting those challenges and serving the public interest. I hope to continue the Department's long tradition of excellent and enterprising work, and I can't wait to give back to the City I have come to call home."

Corporation Counsel Cardozo also extended special thanks to the firms that helped make the clerkship possible. Ms. Cho brings an extraordinary resume to the New York City Law Department. Cho most recently worked as a legal extern at the U.S. Department of Justice in Washington, D.C. Her other public sector experience includes the San Francisco District Attorney's Office, where she externed in the Domestic Violence Unit, and the Office of U.S. Senator Richard J. Durbin, where she developed and advanced the Senator's legislative priorities in food safety, consumer product safety, and public housing issues.

In 2011, Cho served as a legal extern in the New York City Law Department's Legal Counsel Division, where she worked with Law Department staff to advise City agencies and elected officials on legal, policy, and political issues. (Clerkship candidates do not have to have externed at the Law Department, though.)

Ms. Cho will be graduating from Columbia Law School ('12) and has a Master of Public Policy in Health Policy from Georgetown University ('06). She earned her B.A. from Harvard University ('04).

The Corporation Counsel Clerkship offers an unprecedented opportunity for some of the brightest legal minds to gain unparalleled public service experience and access early in their careers, according to Corporation Counsel Cardozo. The program, launching with the initial clerkship, may eventually be expanded to include more than one position.

Ms. Cho will work closely with the Corporation Counsel, the Law Department's Executive Staff, senior attorneys, and City officials. Her responsibilities could potentially include trial court level litigation, appellate work or counseling, and legislative drafting on matters involving significant policy initiatives such as criminal or juvenile justice, the environment, education, social policy, municipal finance, land use and economic development. The clerkship is seen as a way to gain experience and insight into the operations and governance of New York City. Ms. Cho may also have the opportunity to work closely with the Mayor's Office, the City Council and various City agencies.

The Mayor's Fund to Advance New York City, which facilitates innovative public-private partnerships, has worked with the Law Department to raise the necessary support for the program. Funding secured for the clerkship is covering a salary comparable to that of a first-year Assistant Corporation Counsel, including benefits.

As in Ms. Cho's case, recipients would be chosen by a committee of senior executives at the Law Department.
