New York, March 22, 2013 – Corporation Counsel Michael A. Cardozo today announced Andrew Fine as the winner of the New York City Law Department's Corporation Counsel Clerkship. Fine was selected from over 250 applicants.

In November 2011, Cardozo announced plans to initiate an annual one-year clerkship. This is funded in large part by private donations, to be made available to recent law school graduates to work in the Corporation Counsel's Office. The Corporation Counsel Clerkship at the New York City Law Department—modeled on a traditional judicial clerkship—permits high-caliber recent law school graduates to pursue an interest in legal issues relating to local government. The clerkship is the first of its kind in the country. The first Corporation Counsel Clerk, Candice Cho, a Columbia Law School graduate, began work in the Corporation Counsel's Office in September. Fine will begin his clerkship in September 2013.

"We had an extraordinarily competitive pool of applicants this year," noted Corporation Counsel Cardozo. "However, I cannot think of a better candidate than Andrew Fine. His record shows a demonstrable sustained commitment to public service. We have no doubt that he will make valuable contributions during his Law Department clerkship, and we hope this clerkship will give him a strong foundation in legal issues relating to local government law."

Fine echoed this enthusiasm. "I am very excited and honored to be joining the Law Department as the next Corporation Counsel Clerk. The position provides a unique opportunity for a recent graduate to explore the diverse legal and policy challenges that the City faces, and I look forward to working with the dedicated lawyers in the Law Department who serve the City that I love," he said.

Fine graduated Phi Beta Kappa and *magna cum laude* from Harvard College in 2009, with a degree in Social Studies. At New York University Law School, he is a Notes Editor of the Journal of Legislation and Policy and the Frank J. Guarini Institute for Government Scholar. Andrew has interned with the General Counsel's Office of the New York City Council and with the American Center for Political Studies at Harvard.

Corporation Counsel Cardozo also extended special thanks to those firms and individuals who helped make the clerkship possible. The Corporation Counsel Clerkship offers an unprecedented opportunity for some of the brightest legal minds to gain unparalleled public service experience and access early in their careers, according to Cardozo.

Fine will work closely with the Corporation Counsel, the Law Department's Executive Staff, senior attorneys, and City officials. His responsibilities could potentially include trial court level litigation, appellate work or counseling, and legislative drafting on matters involving significant policy initiatives such as criminal or juvenile justice, the environment, education, social policy, municipal finance, land use and economic development. The clerkship is seen as a way to gain experience and insight into the operations and governance of New York City. Fine may also have the opportunity to work closely with the Mayor's Office, the City Council and various City agencies.

The Mayor's Fund to Advance New York City, which facilitates innovative public-private partnerships, has worked with the Law Department to raise the necessary support for the program. Funding secured for the clerkship is covering a salary comparable to that of a first-year Assistant Corporation Counsel, including benefits.

As in Fine's case, recipients would be chosen by a committee of senior executives at the Law Department.
