LAW DEPARTMENT'S FAMILY COURT DIVISION LAUNCHES NEW PUBLIC WEBSITE

SITE PROVIDES INFORMATION ON THE LAW DEPT.'S JUVENILE DELINQUENCY AND INTERSTATE CHILD SUPPORT PROCESSES

New York, August 14, 2013 – The Law Department's Family Court Division today announced the launch of a new website that will serve as a resource for the general public. The website provides helpful information on two core functions handled by the Family Court Division – juvenile delinquency prosecutions and interstate child support matters.

"This is a terrific new resource that explains the juvenile delinquency and interstate child support processes to the public, including to people who may have involvement in one of these matters or who may be victims of delinquent acts," said New York City Corporation Counsel Michael A. Cardozo.

The Law Department's Family Court Division works directly with the public and consists of two units:

- The **Juvenile Delinquency Prosecution Unit** investigates juvenile delinquency matters that are referred to the office and prosecutes the matters where appropriate. These matters involve youth ages 7 to 15 who have been arrested for alleged conduct that would constitute a crime if they were adults.
- The Interstate Child Support Unit appears on behalf of out-of-state custodial parent petitioners who are seeking to establish paternity and obtain child support from New York City residents. In addition, a custodial parent who lives in New York City may seek the Unit's assistance in filing for child support from a parent who lives outside the state or the country.

The Family Court Division is overseen by Division Chief Angela Albertus and Deputy Chief Jennifer Gilroy Ruiz. In 2012, the Division handled more than 6,800 juvenile delinquency referrals and approximately 5,400 new Interstate Child Support cases.
