### SUMMARY:

The meeting was called to order at 6:10 P.M.

**Chair: Henrietta Lyle.** Introduce herself, and welcomed everyone to the January 2013 Meeting and reminded everyone to please stick to the agenda to make sure of a timely meeting.

**Parliamentarian Manny Rivera** spoke in depth about decorum of the community and board members during a board meeting. He emphasized that interruptions and discriminatory remarks will not be tolerated and security will be called upon for future incidents.

**Calvin Solomon of the Special Narcotics Unit** announced the takedown of a doctor indicted on charges of illegally sold prescriptions. He also stated that this form of crime is becoming an increasing problem but is being handled efficiently.
