Public Session

I. Community First opened by 2nd Vice-Chairperson Keith Taylor

1. Senator Bill Perkins spoke about concerns with rats in the subways, and HIV/AIDS in the Harlem community
2. Assemblyman Robert Rodriguez gave an update on what is happening in Albany.
3. Assemblyman Keith Wright discussed efforts to raise the minimal wage, his office's Job Fair, and concerns about the lack of racial diversity in Labor Unions.
4. Representatives from Borough President Scott Stringers, Councilperson Inez Dinkins, Assemblyman Daniel O'Donnell, and District Attorney CY Vance's office gave presentations.

- a. Six Lounge – 2100 Fredrick Douglas Boulevard. **Motion to approve application made and passed by a vote of 27 in favor, 2 opposed with 0 abstentions.**
 - b. Fico LLC – 381 Lenox Avenue. **Motion to approve application made and passed by a vote of 22 in favor, 7 opposed with 0 abstentions.**
 - c. My Image Studios – 46 West 116 Street. **Motion to approve application made and passed by a vote of 28 in favor, 1 opposed with 0 abstentions.**
4. Presentation made from the Executive, Land Use, and Human Service Committees regarding support for Community Options facility at 555 Lenox Avenue. **Motion made to approval this facility made and failed by a vote of 11 in favor, 16 opposed with 2 abstentions.**
 5. Presentation from the Land Use Committee in regard to the Zone Green Text Amendment by the Department of City Planning (N 120132 ZRY). **Motion made and passed to approve this amendment by a vote of 14 in favor, 13 opposed with 2 abstentions.**
