Department of Health notified the office that 410 St Nicholas Ave tested positive legionnaires disease 315 unites affected. Cases reported October 2018 and July 2018. People hospitalized and released.

28th precinct held candle light vigil in memory of the family involved in the murder suicide that occurred on West 121 Street. The husband murdered the wife and daughter and then himself. On Nov 15 we submitted our District Needs as a Board to Department of City Planning. On Nov 19 neighborhood meet with the Department of City Planning and discussed neighborhood improvement housing economic development and land use. Studies on trends in

the neighborhood such as rising rents, new commerce and food and beverage. The District Needs statement is very important to see that we receive the funding for services we need.

Nov 21 met at Red Rooster Harlem for a Harlem Eat Up stake holders meeting. Members from the Marcus Garvey Alliance and the Mount Morris Park Alliance. Proposes to move the Harlem Eat Up event from current location to Marcus Garvey Park. People in the area of the current location are complaining that the park is left a mess.

Nov 22 protest against MTA quality of life policing. Governor Cuomo has appointed 500 new officers. A young child got her foot stuck in the escalator at the Magic Johnson theatre. Luckily she was uninjured.

Committee Reports

Health and Services and Human Committee Resolution of E Cigarettes

City state have been investigating this issue that has created lung issues. Two bills in city council that would ban either flavored e-cigarettes which was passed and menthol cigarettes that is still in the council for consideration. There was much discussion around this resolution because some board members felt the criminal aspect of the issue was not addressed. This may

cause more stop and frisk cases because anyone smoking a cigarette may be stopped if menthol cigarettes are banned. This resolution is still under discussion and is not up for vote tonight. Please email all comments to the board office.

Parks and Recreation Committee

Green Thumb License - Asking for support for this resolution. Currently the licenses must be renewed every 4 years. There are new clauses in the application and the Gardeners are finding some of them egregious.

Clause 7d not withstanding this license is terminable at will in his or her discretion within 60 days and licensee will have no recourse

Clause 15 Waiver of trial by jury

CB10 has 32 gardens, 29 of which are active 1 inactive and two are closed due to safety reason due to construction.

The committee is asking for support of community gardeners in the removal of these clauses. Motion made to support the resolution.

Transportation Committee

Letter of Inquiry: Macombs Dam Bridge, Bus Stop

The location of the bus stop is 155 and Macombs Dam Bridge. Assemblyman Al Taylor is in support of the bus stop. The stop was taken away in the 1980s but never replaced by the MTA. No longer asking the DOT consider a location of Bradhurst and 155 Street for the new BX6 bus stop because it runs under the bridge. Letter will be sent to DOT and we will continue the discussion in the December Transportation meeting. It will be a vote to support the Letter of Inquiry.
