Chairperson Henrietta Lyle: Introduce herself, and welcomed everyone to the April 2015 meeting.

ELECTED OFFICIALS UPDATES:

W. Smith: representative of Assemblyman Keith Wright Office Report:

- The budget was passed: NYCHA was allotted \$100 million for capital repairs
- there will be an MWB Expo on April 17th 2015 at Columbia university

Nina Saxon, New York City Comptroller Scott Stringer's Report:

- The Comptroller's office is offering several seminars to organizations. The flyers are on the tables by the windows
- The office has produced an Immigration manual in extra languages including Russian and French

- R. Woodbury will be the new contact for this area.
- April 18th 2015, there will be a "Youth Women Empowerment" event details TBA

Public Announcements

Claude Johnson: Black 5's Foundation:

Mr. Johnson spoke of the demolition of the Renaissance building on West 138th street. He was not happy about its demise and also made several suggestions on how this can be avoided for future older buildings.

J. Tajiddin had comments that expressed three points

- Developers do not care about Renaissance building and its significance to the community
- Rezoning issues - how developers are going to be building upwards

- Health - He does not believe babies are getting proper air when lying on their mothers' chest covered in heavy blankets. He would like for women in the community to speak to the young ladies about this situation

Renee Harrison:

- Stated that more storage space is becoming more available in Harlem. Workers are stealing people's property and throwing out their belongings at an alarming rate. Currently she is suing the Postal Service and the company "Harlem Storage" for loss of irreplaceable heirlooms.

Ms. Bailey of WHCR Radio (90.3 FM) Voice Of Harlem spoke on these topics:

- Worried about the edifices in Harlem are being destroyed
- The guidelines for rezoning of height requirements in Harlem
- What is going on with the erecting to a new luxury apartment building on 125th Street and Lexington Avenue where Pathmark is currently located.

Dr. K. Samuels has several issues:

- Who is BRP?
- Stanley Gleaton needs to be investigation
- Who is getting all the contracts?
- How come the Success Charter Schools are thriving and the Peterroni School is having a hard time getting established?
- Wants to redevelop a new 197A Plan and wants a committee to help her.

State Senator Bill Perkins:

- Copies of his report are available. The Senator sent a letter to the Mayor about Public Housing concerns.
- The DREAM ACT was not passed
- State is corrupt about where the money is going
- Senator Perkins expressed his thanks to everyone for their support upon his mother's death.
