The November 2012 Health & Human Services Committee meeting was called to order at 6:35 pm with a review of the agenda and an introduction of all committee members.

Ryan/Adair Community Health Center

Mr. Charles Shorter came before the committee to share details on the expansion of services provided at the Ryan Adair located at 124th and Manhattan Avenue in the Manny Wilson Towers. With a grant funded by the Fan Fox Leslie Samuels Foundation the new 'Golden Care' geriatric program provides a full time social worker to provide crisis intervention and social services. The Patient Protection and Affordable Care Act includes changes in management of home health care, the licensed social worker will be available to assist clients with navigating these changes.

Each Tuesday a geriatrician will be on staff joining the daily 4-6 providers servicing the current 500 geriatric patients in the practice along with other 1,000 patients. The goal of the initiative is to develop a sustainable model beyond the 2 year grant by reaching their service capacity; with increased utilization and patient population.

The committee invited Mr. Shorter to provide the general board membership with a brief presentation at an upcoming meeting. He was also encourage by Committee member Henderson to partner with group senior facilities as there is an unmet need for counseling, medical and dental care.

Ms Arenallo visited the committee requesting updated information on services changes toe dialysis and basic chemotherapy therapy at Harlem Hospital. Ms Arenallo is a journalism student at Columbia University and is working for www.MetropolitanMonitor.com The committee members in attendance could not provide an update, however the committee did share with Ms. Arenallo that the outsourcing of dialysis is a HHC initiative that effects all HHC hospitals. She was also advised to research the HHC hearings held regarding this issue. She was encouraged to contact the committee if she had any additional questions and the committee agreed to provide her with an update as soon as one is available from the Harlem Hospital Community Advisory Board.

The plan is to have a committee vote at the December meeting with presentation for a vote by the full board in January 2013.
