LGBTQ Task Force Minutes

Wednesday, June 17, 2015 at 7:30 PM 215 West 125th Street, 3rd Floor Conference Room Hon. Manny Rivera, Chair

LGBTQ Task Force Chair Manny Rivera began the conversation by introducing himself, new Task Force members and some main topics of discussion for the meeting.

Guest James Garcia discussed an upcoming East Harlem Pride event in conjunction with the Harlem Pride event taking place Sunday, June 21, 2015 from 12:00 pm – 6:00 pm at La Marquetta on Park Avenue between West 115th street and West 116th street.

The next discussion centered on a meeting held with Community Leaders and Manhattan Borough President Gale Brewer on LGBTQ issues and community and NYPD engagement.

Key Points from this discussion:

- How Black LGBTQ youth are being handled by NYPD
- Homeless Youth Outreach Centers
- The extension of the LGBTQ Community to from the village
- NYPD training for dealing with the LGBTQ community

The next topic of discussion was Atlah Missionary Church. Manhattan Borough President LGBTQ Liaison Jesus Perez spoke on the Atlah Church signage and how Borough President's office has taken steps to address this issue. On May 4th an Environmental Protection Board hearing was held without representation from Atlah Missionary Church. To date there are currently 5 violations (removed balcony, iron work, signage, installing fence, and replacing doors) totaling \$7500 with a letter of warning sent for a 6th violation which have been assessed to Atlah Missionary Church for changes made to the Landmark façade of the building. Another Environmental Protection Board hearing is scheduled for August 3rd.

The discussion ended with Jesus asking for members of the community to issue their own statements or testimonies regarding Atlah Missionary Church to him with the intent to be additions to the Borough President's letter in order to be a conclusive statement for the community.

The LGBTQ Task Force Mission Statement was given for review and discussion. After review the consensus was in support of the statement as a representation of the task force.

Lastly was a presentation and discussion on Metropolitan Hospital Center which is the only LGBT Health Center in the NYC Health & Hospital Corporation.

The Task Force reached a consensus having an LGBT Town Hall meeting on November 5th with two planning sessions scheduled for September 3^{rd and} October 1st.
