The meeting was called to order at 7:05pm

1. Hispanic Society of America (Elaine Delgado)

The Hispanic Society of America (HAS) is located on 613 W. 155th St. & Broadway (212-926-2234) and offers a variety of FREE educational programs and classes for children, adults, and families. The Society offers various workshops and programs for schools and the visually impaired. HSA collaborates with other institutions around the world to promote Hispanic artwork. A large exhibition from the Society is now on display at the National Gallery in Washington, DC.

The society's mission is to collect, study and exhibit Hispanic culture and art. Their collection includes more than a thousand paintings by Spanish and Latin American artists, 200,000 manuscripts, and so much more. The museum is open six days a week and the library is open five days a week; all are free to use.

The HSA is working on a new website where some of the artwork and study materials will be digitized. A Committee member suggested that HAS try to work on getting larger exposure by working with other institutions like the 155th St. Children's Museum or getting information placed in the tourist info kiosks at Columbus Circle or in Times Square.

The facade restoration is in its final stages; the roof is scheduled to undergo renovation next year.

2. Dyckman Farmhouse Museum Alliance (Meredith Horsford)

The Dyckman Dutch Farmhouse is located at 4881 Broadway & W. 204th St. (212-304-9422) and was built in 1784 by the Dyckman family, who originally came here around 1600. They built the current house after their original home in Inwood was destroyed in the Revolutionary War. Today, the Farmhouse is owned by the DPR and is a member of the Historic House Trust New York City. The Farmhouse is also run by a non-profit, the Dyckman Farmhouse Museum Alliance. The Farmhouse has been operated as a museum since 1916 and next year will be its 100th anniversary. One of the big goals is to better engage our community different ages, groups and backgrounds. The signage at the Farmhouse and flyers are now all bilingual (English/Spanish).

The Farmhouse offers watercolor painting workshops for kids, lectures for adults, group tours and camping outside. So far this year they have many more visits than last year. A listing of events and workshops is available on their Facebook page.

Upcoming projects include: upgrade the lighting and a new roof. The Farmhouse would also like to install an ADA ramp and bathrooms for better accessibility.

3. Parks Update (Jennifer Hoppa)

• Highbridge Ice Rink: no bidders in second round, despite special events, sponsorship and holiday additions

- Highbridge Water Tower: initial cost projection for full restoration/stabilization of the historic water
 tower was projected to be \$3.5M, with just over \$1M projected for the stabilization work to allow for
 public access. After further analysis by our consultant engineer/historic preservation team, Capital
 indicates that with the \$1.27M CM Rodriguez has provided, we can only address roof repairs, granite
 crack repairs and window replacement. It will NOT allow us to reinstate public access.
- Morris Jumel Mansion: perimeter sidewalk and retaining wall work around the Mansion is essentially complete and is expected to be done by the end of November, weather allowing.
- Fort Washington Waterfront: Protecting our children along the New Waterfront Path. NYC Parks and Amtrak are partnering on a fence project to protect users of the Fort Washington Waterfront
- Dyckman ADA Ramp: part of the Fort Washington PlaNYC project, is complete and is being enjoyed by the public
- Inwood Hill Park Pathways at North End, \$1M improvements installed by MTA as part of their ongoing bridge work
- Inwood Nature Center Progress: \$1.85M ADA bathroom renovation complete and the water service construction to 218th Street projected to start this month. New Capital Funding for Nature Center building CM Rodriguez' \$600,000, FEMA \$491,000 and \$750,000 from Public Programs/Recreation. It will cost \$1.85M to make the Nature Center a safe facility again and one that will be more storm resilient in design. NYC Parks' goal is also to make the Nature Center an educational exhibit on storm resiliency and the importance of storm resilient design, the role of marshes, etc. Funding from FEMA for the interior exhibits is still pending. There will be a Public Scoping meeting in early December
- Fort Tryon Park pathways and Palisades Overlook: \$900k have been enjoyed by the public. Open House New York, October 17th and October 18th
- Anne Loftus Staircase to Cloisters \$1.3M Construction is slated to start next month
- Javits Playgroud is fully funded for phase one at \$2.45M. The Fort Tryon Park Trust gave a \$350,000 allocation for capital reconstruction, along with Councilmember Rodriguez' \$1.5M and Gale Brewer's \$600,000, the Phase I project is fully funded. We had a public scoping meeting and expect the Capital Division to come to the Community Board with findings to date/concepts in January.
- There are several on-going volunteer groups that are working on a regular basis in our parks: Morris Jumel Mansion, Dyckman Farmhouse, Natural Area volunteers of Friends of Inwood Hill Park and others.
- Open House New York will have multiple sites that will be open in October 17th
- DPR is working to balance the needs of Moose Hall/Inwood Shakespeare Festival with the BBQ area.
- Free Sailing classes are available at La Marina on October 10th
- 4. Capital & Expense Budget Priorities for FY17 were discussed at length. Each attendee received stickers to indicate which projects and programs were most important to him/her. After these votes were tallied, the collective priority ranking was as follows:

- 6. New Business: Paul Kittas is an advocate for a project at Highbridge Park where he looked at all the ramps. He is looking for a connection between the areas of park between High Bridge and the Harlem River south of W. 181st St. The master plan for the area was done but a feasibility study for that specific area (i.e., between the Alexander Hamilton & High Bridges) is required. This item was added to the Expense Projects list.
