<u>Call to Order</u>: Chairman George Fernandez called the meeting to order at 7:15 pm. No quorum as of yet.

Chairman's Introductions:

- ~ George Fernandez introduced NYC Public Advocate Letitia James who intended to address the group.
- He welcomed back former NYS Assembly Member Gabriella Rosa who has just returned to the community.

Public Advocate Letitia James addressed the meeting noting the following:

- The Public Advocate's Office is in the forefront of bringing about the recent nail salon legislation, securing cameras to be worn by the NYPD, and finding ways to fix the broken foster care system
- She indicated the NYC Pension system is divesting itself of investments in firms that sell guns.
- ~ She indicated that the Public Advocate's Office is encouraging the Federal Government to pass legislation that will ban assault weapons and will require background checks.
- ~ She indicated that the Public Advocate's Office is behind efforts to provide affordable housing for the more than 50 thousand homeless New Yorkers, a third of whom are children.
- ~ To contact the Public Advocate's Office, call (212) 669-7200.

New York State Assemblyman Herman D. Farrell, 71st AD addressed the meeting noting the following:

~ Construction on 151st Street Pedestrian Footbridge has begun. The construction phase of the long-awaited pedestrian footbridge into Riverside Park at 151st Street and Riverside Drive is

underway.. This project will cost \$20 million in State funding. The DOT Plan plans to plant three trees for each tree removed. The project is expected to be completed by December 2016.

NYC Councilman Ydanis Rodriquez, District 10 addressed the meeting and reported the following:

- ~ He thanked members of CB 12 who have participated in the participatory budgeting process~
- He invited everyone to participated in the October 3rd meeting regarding the "Inwood NYC" Project. It will replace the former Sherman Creek Project and involves the development of approximately 100 acres from Dyckman Street North from Broadway east to the river. HPD, City Planning and other agencies will be at the meeting to get community input. The meeting will be held at PS 5 from 10:00am to 1:00pm.
- ~ The plan to bring an outdoor skating rink to District 10 did not receive any bids. The \$2 million that had been set aside for the rink will be re-appropriated to meet other needed services in the community.
- He is interested in bringing ferry service to the west side of Manhattan including stops at 72nd St., 125th St., George Washington Bridge and Dyckman Street.
- ~ He is interested in improving the safety of transportation and is convening a meeting at NYU for the purpose of pursuing the matter further.
- ~ He has introduced 3 bills to improve intersection safety, better lighting at trouble spots and turning signals.
- He complimented the various restaurant owners in the community who have demonstrated a willingness to make improvements in noise reduction, earlier closing hours and prohibition of hookah use.

Quorum was reached at 7:48pm. Separate motions were made and passed by a voice vote to do the following:

- Delete # 15 and # 28 from the Agenda. (The applicants have withdrawn their applications at this time. CB 12 needs to notify the SLA that these establishments need to come back.)

George Fernandez announced that James Berlin will serve as Parliamentarian at this meeting.

Chairman's Report: George Fernandez announced the following:

- The 33rd Precinct will add 6 Peace Officers to ensure public safety due to recent problems that have occurred at the 168th Street Men's Shelter.
- ~ He encouraged all CB 12 members to attend the planned October 3rd meeting on the "Inwood Plan" that is scheduled to be held at PS 5.
- ~ He announced the following changes to the CB 12 Committees:
 - Felipe Wytik Sanchez will be Assistant Chair Housing & Human Services
 - Arlene Schulman will be Assistant Chair Health & Environment
 - Elizabeth Lorris Ritter will be Chair of Parks & Cultural Affairs

 - Ayisha Ogilvie has been reappointed to chair the IT Committee
- ~ He is looking for Assistant Chairs for (2) Committees Business Development and Public Safety
- ~ He announced that Kelly Boyd and Lorenzo McGougan have resigned from the Board.

- ~ He announced that on September 30th at 6:30pm there will be a NYC Participatory Budget meeting at the Campbell Sports Center to discuss how \$1 million is to be spent.
- ~ He announced that there will be meeting of ANMARK meeting at CB 12 offices on Monday October 5th at 6:30pm

District Manager's Report: District Manager Ebenezer Smith announced the following:

- There will be a Public Meeting on Wednesday, October 21st to review District Needs.
 This will enable us to modify the Statement of District needs.
- The West 190th Street station on the A line is in poor condition. He is working to have the MTA to have the elevators improved in time for the Medieval Festival and to have the station painted. In addition there are long-term needs for the station that need to be addressed.
- The Medieval Festival will take place on Sunday, October 4th in Fort Tryon Park.
 Parking will be difficult on that day
- He is working with the NYC Department of Buildings regarding the legality or illegality of the Omega Laundromats which is operating at 614 West 157th Street.
- ~ There will be a Small Business Fair on October 7th from 10:00am to 12:30pm that will be held at 530 West 166th Street 2nd floor.
- PS 4 has 3 air conditioners on the roof that make a lot of noise. Residents in buildings across the street complained. He has held a meeting with the school and the residents to see what can be done.

George Fernandez – introduced Community Policing Officers – Officer Perez & Sargent Garcia of the 33rd Precinct who reported that they are not opposed to the following resolutions.

Borough President's Report - Northern Manhattan Liaison, Giovanni Puello presented the following:

- Borough President Brewer wrote a letter to Police Commissioner Bratton regarding the issues arising from the Men's Shelter at the Armory. The response indicated that the NYPD is aware of the Borough President's "NYC Safe" initiative and will place additional officers on duty to provide additional security.
- The School Annex Building located in the playground between 168rth and 169th Streets needs to be removed and the playground restored. The Borough President has written to the Parks Department and wants the Parks and Education Departments to work together to restore the area.
- ~ The Police-Community Relations Report is being released following interviews with more than a thousand New Yorkers. The report contains key proposals that will be reviewed.
- ~ The Borough President's Office will plans to sponsor a Small Business Forum in CB 12M.
- ~ The Borough President's office is seeking interns for the Fall. Check the web site for details.
- ~ The Borough President hosted a public meeting on September 17th concerning traffic congestion. Further discussions will consider congestion pricing, Bridge tolls, etc

Public Session – Isaiah Obie Bing administered the Public Session and the following individuals spoke:

- Martin Collins spoke about the role of the Empire State Development Corporation in providing free business counseling and small business loans for Veterans.

 He also spoke about the Medieval Festival that is to take place on October 4th.
- Mayela Calderon, Community Outreach Coordinator, Brothers and Sisters spoke about an interest in expanding the services into Washington Heights & Inwood.

 They have t(3) goals recruit volunteers, expand services and identify job resources.
- Salieen Shah spoke about the Citizen's Committee for NYC and the need for grant applications. Due date = January 25, 2016. Grants are for \$500 3,800. Call (212) 822-9580 or check the web site: www.citizensnyc.org
- Danita Nichols of the New York Public Library spoke about the fact that the Inwood Library will be open 7 days a week. As of December 1, they are adding staff, increasing hours and expanding programming. In addition the Fort Washington Branch will be renovated. The History Project is continuing.
- **Dr. Karen Ellefsen**, Isabella Early Childhood Education spoke about the intergenerational center for children from the ages of 3 months through 5 years. There will be an Open House on Wednesday, November 11th.
- **Mitch Glenn** representing the Residents of Sylvan Terrance spoke in support of Resolution #2.
- Nayma Silver spoke about a Fashion Show she had at the Dyckman Houses. She is looking for a venue and other community supports to afford an opportunity to schedule another Project Beauty Institute for young women in the community.
- **Mary Eyre**, Community Resident, spoke about her concern about safety problems caused by bikers and requests more transparency in the planning process.
- Joel Yoffie spoke for Phil Zarblocki, Advocates for Public Integrity, about overcharging by the Armory. They wanted \$1,850 for (3) hours of use of the space. This matter has been brought to the attention of Rodriguez' office and the Mayor's office but no action has followed.
- **Dr. Gary Altheim**, Executive Director, Growth & Development Services, thanked everyone for making "Reach Potential Arts" program a success. The Program ran on subsequent Tuesdays. For more details, consult the web site: www.excelgds.org.
- **Arelia Taveras** (and Group) spoke in support of Resolution #26. She (they) indicated that many community residents have signed a petition in support.
- **David Friend**, Community Resident spoke of the 500 foot rule governing establishments serving liquor and registered his opposition to Resolution #28.
- **Katie Weaver**, Community Resident, spoke in support of the restaurant in Resolution #26.. **Katherine O'Sullivan**, MFU (Moving Forward Unidos), (and 20 others) complained about the exorbitant number of liquor licenses on Dyckman Street.
- Ana Maria Gomez, community resident, spoke in approval of Resolution #26.
- Michael O'Boyle, spoke in support of Gregory Gonzalez, owner of Kon'to Euro Caribbean Cuisine Corp. and recommended that the Board approve \the application.(Resolution #26).
- **Seny Taveras**, Executive Director, CUNY in the Heights, also spoke in support of Mr. Gregory Gonzalez and the educational work he plans to do with students from CUNY in the Heights. (Resolution #26).
