Presentation by John Novick, Mayor's Office for People with Disabilities (MOPD)

- ~ One of eight New Yorkers suffer with a disability
- Discussion about Local Law 28 which requires city agencies to include information about accessibility to locations hosting events. All sites for meetings should offer accessibility.
- ~ Community Boards should but are not required to comply with this law.
- ~ For city agencies:

All ads and notices about meetings must contain

- Information about accessibility
- Notice about accommodation for those with a disability
- Deadline before the event as to when accessibility can be requested
- Name of the contact for this request
- Must identify the types of accommodation offered for example,
 wheelchair, assistive listening systems, and other types of accommodation

Land Use - Chair Wayne Benjamin reported the following:

There were (2) applications that came up for review:

- 420 West 160th Street requires approval for an interior renovation of a building located within the Jumel District
- 2420 Amsterdam Avenue (181st Street) requires approval of 4 variances in order to construct a hi-rise building intended to accommodate mixed use. A Resolution will be presented in the January meeting.

Youth & Education – Avisha Ogilvie reported the following:

There were (2) presentations at the most recent meeting:

- Beauty Project at Nagle Avenue
- WIND Music School

Licensing – Osi Kaminer reported the following:

There are 13 Resolutions that came up for review and will be presented at the General Meeting

- ~ (1) is a wine restaurant with no music
- (2) were requesting liquor license renewals but were not prepared and will be back in January
- ~ The remaining were requests for renewals.

Housing & Human Services: Ayisha Ogilive, Chair reported the following:

In anticipation of problems arising from rezoning, the Manhattan Legal Services made a presentation about legal clinics they plan to offer for the community

The Committee is sponsoring a joint resolution with Traffic and Transportation to support the proposal for reduced fare for metro cards for special categories of citizens.

Parks & Cultural Affairs - Elizabeth Lorris Ritter, Chair reported the following:

There were two Resolutions that were discussed & voted on – and will be presented at the General Meeting:

- ~ A Resolution in support of a proposal to renovate Inwood Hill Park Nature Center
- A Resolution in support of the construction of an Adult Outdoor Fitness Center on Dyckman Street in Inwood Hill Park

Health & Environment - Steve Simon, Chair reported the following:

Con Edison made a presentation at the last meeting concerning an update on the electrical distribution system

Young Lord Associates made a presentation regarding their plan to clean up the site at 2420 Amsterdam Avenue. They are Consultants to the developer.

The Committee is co-sponsoring a Resolution with Youth & Education and with the LGBT Task Force regarding the need of the NY & NJ Port Authority to construct a fence to thwart suicide attempts from the Bridge.

There was some discussion about having the PA attend an upcoming meeting to address this issue. There was also a discussion about the wisdom of presenting questions in advance to the PA.

The next Health & Environment Committee meeting will take place at the Russ Berrie Building at CUMC where the School of Nursing will discuss some of their latest initiatives.
