**-Chair Saneaux** informed having participated @ **Public Safety Committee's** last meeting, at the invitation of chair **Ms. Schulman**, to start considering a joint meeting between Aging and Public Safety Committees, in order to mutually address crucial situations faced due to the vulnerability of seniors and current wave of different crimes within the community. **-Officer Perez – Community Affairs 34<sup>th</sup> Pct.** gave statistics on the current situation within the community and summer events within the precinct.

**-Mr. Levi**off-Seniors **Orchestral Society of New York** made his presentation, outlining projected presentations by the orchestra; how the organization operates and aspirations in the near future. **Mr Levi**off also informed that **Councilman Rodriguez** has pledged \$5,000 to his “**Seniors Orchestral Society of New York**” organization. Chair **Saneaux** promised Mr. Levioff to contact **Mr. Maurice Maurice Owen-Michaane**, Chair of Business Development Committee, so that Mr Levioff can make his presentation to this committee
