RE: 422 West 160th Street – Interior Alterations and Building Extension

Dear Commissioner Srinivasan:

At Community Board 12 Manhattan's General Meeting, held on Tuesday, December 20, 2016 the following resolution passed with a vote of (30) In Favor, (0) Opposed, (0) Abstain supporting the interior alterations and extension proposed for 422 West 160th Street, New York, NY.

Whereas:

422 West 160th Street (Block 2109, lot 29) (the "Property") is located on the south side of West 160th Street, between Edgecombe Avenue and St. Nicholas Avenue, within the Jumel Terrace Historic District. Alterations to buildings located within historic districts must be reviewed and approved by the Landmarks Preservation Commission ("LPC"); and

Whereas:

The Property is a three story building with basement/garden and cellar levels. It contains four residential units. The proposed alterations to the Property include interior renovations, including new kitchens, bathrooms and general construction, and an 11-foot deep extension (the "Extension") to the rear of the Property (collectively, the "Alterations"); and

Whereas:

The Extension increases the floor-plate of the basement/garden level, parlor/first floor and second floor of the Property. The floor plate of the third (top) floor remains unchanged. The roof of the Extension will serve as a terrace for the third floor unit. A recreation room for the basement/garden level unit is created at the rear of the Cellar level and connected to the unit via a new internal stair; and

Whereas:

No work to the Property is proposed that impacts its street-façade or is visible from the public street or sidewalks; and

Whereas:

At the December 7, 2016 meeting of Community Board 12- Manhattan's ("CB12-M") Land Use Committee ("Land Use" or the "Committee"), the project architect, S M Tam Architect PLLC, presented the design proposal for the Alterations. Now, therefore,

Community Board 12-Manhattan supports the interior alterations and extension proposed for 422 West 160th Street.
