	signage identifying the business. A woman at the premises,
	whom Mr. Garcia has identified as the manager, Denicia
	Mena, falsely claimed to be the owner of the establishment
	when the police inquired. The police ordered the applicant to
	cease and desist from selling alcohol due to the lack of
	proper licensing, and that order appeared to have been
	obeyed. However, when the Lieutenant visited the location
	again, he noticed that alcohol, which cannot be stored legally
	with a retail license or warehousing permit, was still being

Community Comments	 kept at the bar. The applicant was then ordered to remove any and all liquor from the premises, which appears to have been done. The previous establishment at this location, Clara de Luna, had an extensive history of noise complaints and after hours consumption of alcohol. Community members present were concerned that this establishment was opened without a liquor license, that enforcing the relevant laws at establishments like this places additional strain on resources that could be required elsewhere in the District, and that approving this license conditionally may be a mistake, as waiting two years until the first license renewal
	to revisit this is too long a time.

Notes	 This is the only establishment owned by German Hernandez, who purchased this business from Pablo Amparo and was not present at the Committee meeting. During questioning, the manager stated that the last time this business was open was on October 31st, making no mention of the New Year's Eve incident which would later be described by the police. He stated that he had been misled into believing that the premises were indeed licensed by the applicant's attorney, who turned out to be an accountant offering legal advice without a law license. However, the license certificate presented to the police, in addition to belonging to the previous owner, was also expired. The representative stated that the manager was an honest man who had learned from his mistakes and was just following orders, but the Committee Chairman expressed concern about a manager who is unable to distinguish between legal and unlawful orders and about a proprietor who does not seem to understand the simplest mandate under the ABC law – that any business is prohibited from serving alcohol without a proper license – and leaves little reason to believe that any of the other extensive requirements of the law will be met. Other committee members also had serious reservations regarding this transgression. If this license is granted, the applicant expects to open at the end of February.

34 th Precinct	 The 34th Precinct expressed serious concerns about the saturation in the area with so many people exiting several businesses, including Cliff and other nightclubs behind this building, at around the same time. The Lieutenant noted that stipulations are difficult to enforce and that the NYPD can only report violations thereof to the SLA, which would investigate and take action if warranted. It was suggested that the owner maintain regular communication with the Precinct's Neighborhood Coordinating Officers and she agreed to do so.
Community Comments	Some members of the community are concerned about saturation in this area. It was noted that at meetings with State Senator Adriano Espaillat, Dyckman Houses residents have complained of noise and parking spaces being taken up by nightclub patrons.

The space has been divided into three slots for establishments; another will also be a restaurant, and the third is a proposed billiard hall. The representative indicated that this establishment could be a source of employment for neighborhood residents. One committee member noted that there's great potential for the drain of police resources in this area, which could present a safety issue for the greater community.
