Welcoming Remarks from Arlene Schulman and Liliana Saneaux noting that this is a Joint meeting organized in light of Domestic Violence Awareness Month to address issues of Elder Abuse of interest to both committees.

#### Catherine Christian:

- Elder Abuse: any case in which victim is over 60 years of age triggers notification in Elder Abuse Unit
- Perpetrators can be family members, caregivers, neighbors,
- Types: Physical Abuse, financial abuse (fraud, theft), human trafficking
- Majority of victims are female
- Most common case type is financial
- Resources: HOTLINE 24-hr voicemail, Witness Aides, Social Workers,
  Language assistance available, non-criminal cases referred to appropriate
  agencies including NYC Dept. for the Aging

#### Verna Arthur:

- There is much case consultation collaboration with DA's Elder Abuse Unit
- NYC Dept for the Aging Funds Neighborhood Initiatives like Community Elder mistreatment and Abuse Prevention at Carter Burden Center for the Aging
- Other Resources:
  - New York City Connects: resource guide for disabled and caregivers.
  - o Thrive NYC: Mental Health Support

#### Q&A

Richard Lewis: Abusive Landlords who target seniors for illegal evictions and abuse in Nursing homes

Catherine Christian cited recent cases with indictments of landlords pending; all nursing home issues are the purview of the Attorney General

Joselinne Minaya asked any complaints be referred to her office

Arlene Schulman: single most moving case

Catherine Christian: cognitively impaired neighbor conned into signing a power of attorney to the neighbor who then redirected funds and deposits into a joint account. Case was flagged by a social worker doing a well visit.

Fern Hershberg: Are these agencies able to investigate systemic landlord abuse by single management companies?

Catherine Christian: recommend the DA's tenant protection unit Arlene to officers: How do they respond to elderly they suspect of neglect or abuse?

Officer Danny Guzman of the NYPD's 33<sup>rd</sup> Precinct: officers much approach elderly carefully and with respect lest they appear to insult them. He reiterates that reports with a witness over 60 gets flagged for referral to Elder Abuse Unit or NYC office for the Aging.

Verna Arthur: expresses her objection to the Committee for the Aging meeting in the evening
