Ilana Dunner: Offered to NYLPI space @ Riverstone for the housing clinic – also presented Memory Center programs offered by the Senior Center

Liliana: Expressed her satisfaction to have brought together 3 organizations which can work as a team, and would like to consider organizing a community forum on NYLPI issues

Mary: Revisited the idea from our last meeting of having a joint meeting with WHICOA and also elected officials, to discuss needs of seniors, what their agenda is regarding those issues, and

how we can work together – Liliana felt that we should wait until everyone is inaugurated and settled, but agreed to engage with Rose Mary to plan for it.

Fern: Raised possibility of inviting Joselinne Minaya from DA's office to a meeting to answer questions involving elderly and crime — **Liliana** said Joselinne has also offered to host one of our meetings. She also delivered an updated list of Senior Centers within CB12 area as promised and emailed to Mr. Ebenezer Smith
