## **Discussion that took place as indicated below:**

- 1. Dr. Susana De Jesus, Director, Education Unlimited Lyceum Charter School (*EULCS*), made presentation about the pending proposal for the new Charter School EULCS in the School District 6. Dr. De Jesus has been an Educator for over 30 years, serving is different capacities and school grade levels. She provided a detailed summary of the school proposal as follow:
  - ✓ EULCS' team is comprised of twelve professional educators in their respectively field, of which four of them were present at the meeting. The school's mission is to facilitate: "rigorous and high caliber program for every K-12 child, through a language campus, with after-school, summer-school and sports programs."
  - ✓ Some of the areas in which the schools are proposing to concentrate include: "Dual-Immersion, Teaching Torelerance, 100% Literacy, Cambridge Primary, STEM Education, Extended Day, Parent and Community Involvement " and ample details were provided on each of these areas. The present also discussed the urgent education and economic needs in the school community of District 6, such as:
  - ✓ Over-crowded Schools
  - ✓ Demand for UPK Out Pacing Supply
  - ✓ Only One G&T Program in the district
  - ✓ Public Schoo9ls Finish at 2:30pm
  - ✓ Insufficient After and Summer School Programs
  - ✓ Low Students Achievement
  - ✓ High Poverty 21.2%
  - ✓ High Unemployment Rate 10.3%
  - ✓ High Displaced Labor Force 33.6%

- ✓ 31.5% of working Adults do not have HS Diploma
- ✓ High Rate of Crime
  Presentation materials were provided for committee's members containing well elaborated report for the school's proposal.
- 2. Ryan DuBois, Associate Human Rights Specialist Manhattan, NYC Commission on Human Rights made a presentation address the topic Human Rights Law 101. Presented provided an overview of the NYC Human Rights agency's mission and also discussed at length the following:
- ✓ How and where to file a complaint and the time frame involved to file the report.
- ✓ Commission's services are provided free of change.
- ✓ Appointment can be scheduled via telephone at either 311 or (718) 722-3131
- ✓ Illegal areas of discrimination were discussed among the subject of employment, housing, public accommodations, discriminatory harassment, bias-based profiling by law enforcement, lending practices, and retaliation.
